## Highlights (last 30 days)

Sacramento River Erosion (SRE): Contract 2 Season 1 is complete. Contract 4 bids were received. Contract 2 Season 2 and Contract 4 are on track for 2024 construction!

Sacramento River East Levee (SREL): Contract 3 is complete. Contract 4 is over 85% complete and will continue into 2024 due to project delays near the Westin Hotel.

### Looking Ahead (next 30+ days)

#### What can I expect?

#### SRE

Tree cutting through February 15, 2024, in preparation for Contract 2 Season 2. Note: There is no need to cut trees in preparation for Contract 4.

#### SREL

Production Jet Grout drilling will continue at Garcia Bend Park and Sump 132 and complete by mid-January 2024. Jet Grouting at Westin Hotel will resume and continue into 2024.

Hours of Operation: Mon – Sat from 7 a.m. - 7 p.m.

#### Garcia Bend Park Staging

- ◆ Boat ramp closed during construction at the City's request with intermittent vehicle traffic during construction.
- ◆ Garcia Bend Park will have light traffic in and out until the end of the year.
- ♦ Jet Grout cutoff wall work has resumed and will be ongoing until end of December. Anticipate 20-30 truckloads of spoils off-hauled out of Garcia Bend Park throughout construction.

#### **Sump 132**

- ♦ Work anticipated to continue through December.
- ◆ Drilling at Sump 132 and spoils management at Garcia Bend Park will be occurring during this time.

### Cliff's Marina

◆ All work from Cliff's Marina to Freeport Bridge is complete.

#### Westin

- ♦ Levee cutoff wall work will continue through May 2024 due to delays in construction.
- ◆ Sump 41 pump station construction is complete.

## **Question of the Month**

In preparation for the coming construction season, tree clearing is completed from November 1—February 15. What drives this date range?

Birds like the hawk, magpie, and osprey tend to nest during the same period (late February through October). The Migratory Bird Treaty Act of 1918 prohibits killing, capturing, or handling protected bird species, including their nests and eggs.

While we can technically survey for birds and remove trees at anytime during the year, removing trees from November 1—February 15 is a best practice. If we discover a tree requiring removal during the avoidance period (late February through October), it cannot contain an active nest and a bird monitor is required to be onsite during removal activities.


