The delineated stream channel and wetland are isolated features that drain toward, but do not reach, Crescent Valley and have no direct or indirect connection to the Rye Patch Reservoir. The Rye Patch Reservoir is the closest Traditional Navigable Water (TNW). The subject channel has a discrete termini outside the project boundary and no connection to a downstream tributary or waterbody. Therefore, the wetland and channel within the delineation boundary are isolated, intrastate waters with no connection to interstate commerce and are not iurisdictional.

#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
