### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

local groundwater discharge, snowmelt runoff and precipitation. The basin is confined, has never been connected to the Eagle River, and is separated from the river by the moraine. These wetlands are approximately 35-40 feet higher in elevation than the Eagle River. In 1995 an area was excavated through the moraine, and culverts were placed under the access road and Hwy 24 to help drain the reservoir. However, direct observations on June 3, 2016, identified that this drainage path is relic because it currently does not exhibit an OHWM and is populated with upland plant species. The Bolts Lake wetlands are approximately 690 feet from the Eagle River and its 100-foot floodplain and are not considered adjacent from a physical or regulatory perspective.

Highlands (H) Wetlands are located upgradient, approximately 100 feet in elevations, from the Bolts Lake wetlands (wetland BL) and separated from Cross Creek wetlands by a natural ridge that acts as a hydrologic divide. While the Cross Creek wetlands flow to the west to Cross Creek, the flow path within the isolated wetlands are easternly. These wetlands are comprised of a complex of wetland depressions that hold enough snowmelt and precipitation to sustain hydrophytic vegetation. The North Ditch (aka Bolts Ditch) historically conveyed groundwater discharge from a diversion on Cross Creek through the Highlands wetlands to Bolts Lake for storage. However, this diversion on Cross Creek was removed under the direction of the US Forest Service in the fall of 2010. Currently, the ditch only conveys overland sheetflow from snowmelt and groundwater discharge, which generally infiltrates within the ditch prior to reaching Bolts Lake.
