C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

At the point of confluence with the Virgin River and two large ephemeral drainages (Lizard and Atkinville Wash), the Virgin River exhibits the characteristics of a navigable in fact TNW, having both demonstrated navigable capacity and interstate commerce connections. While the Saint George area only receives 8 inches of precipitation annually, much of the precipitation falls during intense storm events, which are especially common during the monsoonal months of July, August and September. The runoff that flows through the ephemeral streams within the project area during these events are able to carry pollutants, sediment and organic matter to the Virgin River. The ephemeral streams within the project area, in conjunction with other tributaries within the greater Saint George area, are crucial in maintaining the stream dynamics of the Virgin River.**

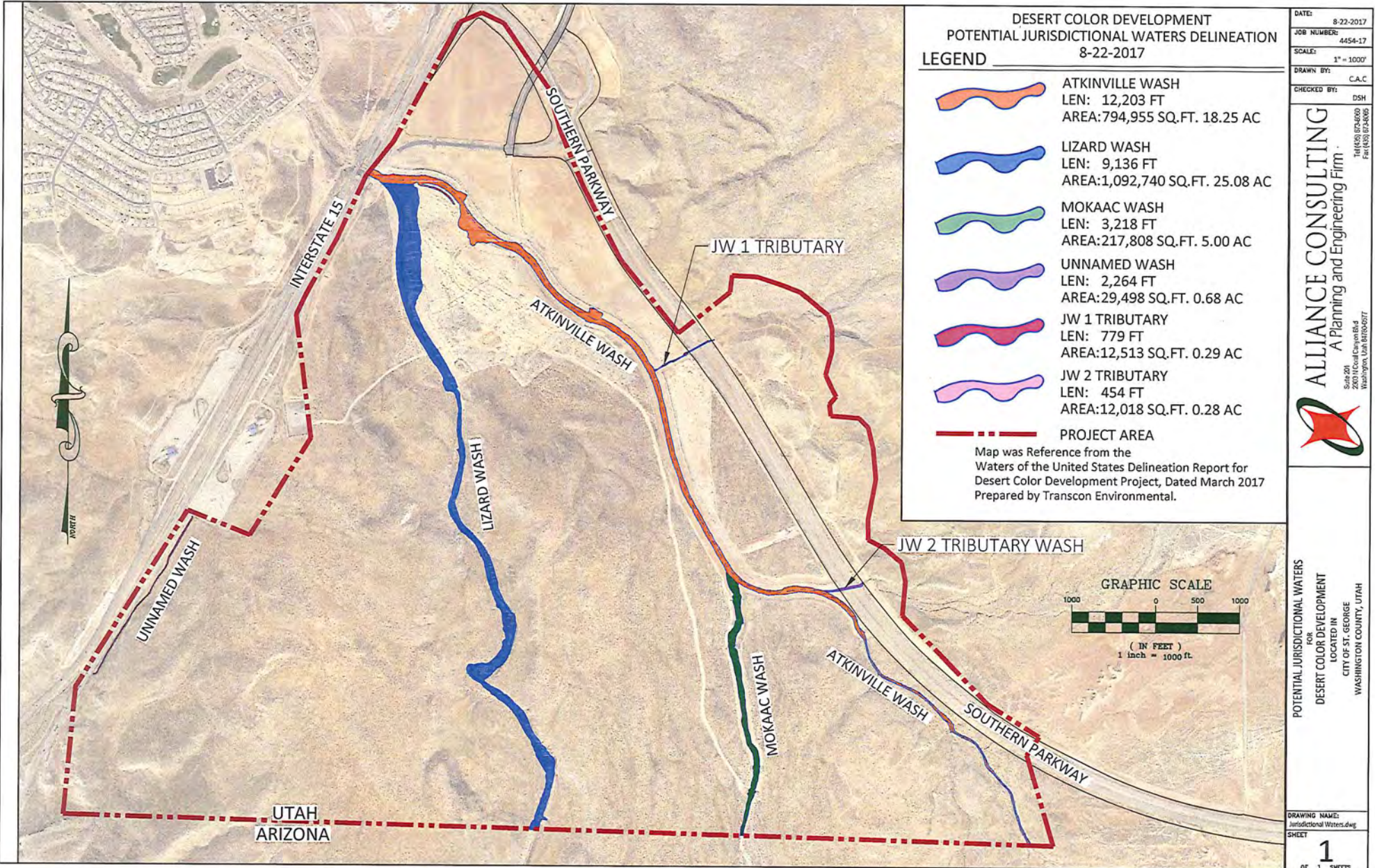

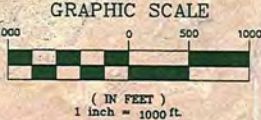


DESERT COLOR DEVELOPMENT
