# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

☑ Other: (explain, if not covered above): Wetland W-3 (1.95 acres) is classified as palustrine emergent and is created from an elevated ditch that leaks and is an artificial hydrology source for the subject wetland. This was made evident from site visits made by the Corps on May 10<sup>th</sup> and June 7<sup>th</sup> of 2017. During the May 10<sup>th</sup> site visit it was clear that water was flowing from the elevated ditch into the subject wetland through a break in the ditch. To demonstrate that the hydrology is irrigated induced the property owner was able to turn off the ditch on May 27<sup>th</sup> and verified with photos that the subject wetland was dry on May 30th. The Corps made a second site visit on June 7<sup>th</sup> and the entire W-3 was completely dry. While the remaining site wetlands were saturated to the surface and inundated. This was also during a spring with above average precipitation.
