Explain: The subject area covers approximately 130,574 acres in two study areas: The "Sevier Playa" study area, which covers 123,519 acres and the "Utility" study area, which covers 7,055 acres.

The Sevier Playa study area was evaluated during 2013 under this same project file number (SPK-2013-00295) and at that time the Corps determined that a 122,423-acre feature identified as "Sevier Dry Lake- Playa Boundary" was an intrastate isolated feature with no apparent interstate or foreign commerce connection. The Sevier Playa study area was re-evaluated during 2017 to determine if any change had occurred. The re-evaluation determined that there is no ordinary high water mark (OHWM) associated with this feature and that the feature is not an aquatic resource. As stated in the Corps previous determination for this feature, Sevier [Dry] Lake is a remnant of ancient glacial Lake Bonneville and is located in a closed basin at the terminus of the Sevier River and does not drain/connect to a TNW. Water from the Sevier River is almost entirely diverted for irrigation purposed throughout the upstream length of the river prior to its confluence with the Sevier [Dry] Lake. Therefore, Sevier Lake has been virtually dry throughout recorded history except for brief periods of unusually high precipitation and runoff in 1913, 1922, mid 1980s, and 2011. The area is not navigable and cannot be tied to interstate or foreign commerce due to absence of water. Sevier [Dry] Lake does not consistently or regularly receive water such that physical indicators of an OHWM could develop. The nearest TNWs, Mona Reservoir, Sevier Bridge Reservoir (Yuba Lake), and Paiute Reservoir are approximately 80 miles northeast, 56 miles east, and 68 miles southeast of the study area, respectively. Mona Reservoir is located in a different watershed and both Paiute and Sevier Bridge (Yuba Lake) Reservoirs are located upstream of Sevier Lake. Sevier Lake is an intrastate, isolated feature with no interstate or foreign commerce connection.

The Utility study area was evaluated for the presence of aquatic resources during 2017, and the evaluation revealed the presence of seven wetland areas (W01, W02, W03, W04, W05, W06, and W07), totaling 6.88 acres, and four ephemeral drainages (P12, P14, P17, and P26) that exhibit an OHWM, totaling 5.52 acres. While the seven wetland features meet the wetland delineation criteria in the 1987 Wetland Delineation Manual, those features are in the Sevier [Dry] Lake watershed, described above and have no connection with a TNW. Similarly, while the four ephemeral drainages may occasionally contribute water to the closed basin Sevier [Dry] Lake, the dry lake has been determined to be uplands, and therefore the ephemeral drainages do not connect to a TNW. Based on the above, the seven wetlands (6.88 acres) and four ephemeral drainages (5.52 acres) in the Utility Study Area are each intrastate, isolated features. No interstate or foreign commerce connections could be attributed to any of these aquatic resources

significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
