This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The 2.75 acres of wetland directly about a 3.76 acre pond (Relevant Reach 2) that is connected with the Jordan River through two box culverts. The 1,038 linear feet of storm water ditch (Relevant Reach 1) a seasonal RPW) flows south through a culvert under the Jordan River Trail into a perennial tributary that flows west into the Jordan River. The Jordan River flows north approximately 25 river miles north into the Great Salt Lake, the nearest traditional navigable waterway. Therefore the 2.75 acre of palustrine emergent wetland, 3.76 acres of open water and 1,038 linear feet of storm water ditch are jurisdictional.
