**B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND:** The entire 4.37-acre site consists of dry land with no features exhibiting wetland or open water indicators. The site is near the toe of a slope and had likely been irrigated in the past, which supported some stands of *Juncus arcticus*. The site is no longer irrigated and has no other hydrology source. Data points confirmed that the site does not meet the wetland hydrology or soil parameters.
