Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **A previous jurisdictional determination for this 5,627-acre parcel was made on February 27, 2013. The jurisdictional verification has expired and the land owner has requested it to be renewed. Ten wetlands (totaling 1.07-acre) were located within the survey area were determined isolated and non-jurisdictional. The survey area consists of 5,627 acres on the north, east, southeast, and southern borders of the Bingham Canyon Mine, operated by Kennecott Utah Copper LLC. The eastern section of study area contains a lined stormwater canal and the South Area Water Collection Pipeline. These collect surface and groundwater through a system of cutoff walls and collection pipes from the**

perimeter of the Mine and deliver the water into the Industrial Process Water System. This system was determined to be non-jurisdictional in a previous Approved Jurisdictional Determination (SPK-200901213-UO). Isolated wetlands 1, 2, 5, 8, 9, and 10 have all been excavated for mining activities. Isolated wetlands 4 and 7 have been filled for mining activities. The only remaining wetland is wetland 6 (0.2 acre), which was previously determined isolated and non-jurisdictional, as were the excavated and filled wetlands. Wetland 6 is downstream of the lined stormwater canal in a basin that is isolated by a small berm that prevents any flow from leaving the study area. The Environmental Protection Agency concurred with this isolate determination on February 14, 2018.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
