Dotentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Ditch D (710 linear feet) and Ditch E (156 linear feet) were determined to be preamble waters, as they are seasonally flowing, man-made ditches that are excavated in uplands and terminate in uplands after flowing northwest through various agricultural fields, and being flumed across the Weber-Provo canal. Wetland A (0.092 acre) and Wetland B (0.091 acre) were determined to be non-jurisdictional due to surface flow patterns leading from the wetlands and into a preamble water (Ditch D) and an isolation from all other waters of the US. Wetland C (0.074 acre) is an artificial wetland, which has been previously determined to be in existence solely due to the irrigation overflow from a nearby ditch. This overflow has caused an irrigated wetland that would revert to dry land

should application of irrigation water to that area cease, which can be seen by topographic depression in which the wetland is located and the heavily saturated, gravel soils that channel seepage from the adjacent ditch. This determination is further supported by a previous determination made on the site in 2009, which also determined the wetland to be irrigation induced (SPK-2008-01547).

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. #### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
