2. Non-regulated waters/wetlands (check if applicable):³

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

The 0.72-acre wetland located on the extreme east end of the study area was investigated by Corps personnel on October 9, 2019 for potential connections to off-site waters. A culvert was located under Arrowhead Trail Road, east of and adjacent to the study area boundary. Initially, it was thought that the subject wetland could potentially drain east and into a ditch that flowed south through this culvert and into other wetland features east of the Salem Rodeo Grounds and Public Works property, though the flatness of the area made this unclear. Upon further analysis, including elevation information obtained from the Digital Globe website, it was determined that, in the event of the area receiving sufficient surface water, the culvert would convey flow north under Arrowhead Trail Road and into the topographically lower wetland in the study area. perimeter of the subject wetland was investigated for any other potential conveyances, connections or drainages leading away from the depressional area and none were found. The Corps has determined that the 0.72-acre feature identified as 'A' on the delineation maps is an intrastate, isolated wetland with no apparent interstate or foreign commerce connection and, as such, is not currently regulated under CWA Section 404.

The 0.15 acre wetland located on the extreme west end of the study area was also investigated by Corps personnel on June 20, 2019 and October 9, 2019 for potential connections to off-site waters. This feature was created from a leaking well that drained to the west and into an irrigation ditch extending to the north. This ditch has been abandoned in recent years and much of it does not exhibit wetland characteristics or OHWM indicators. The portion of ditch that met wetland criteria does not extend far from the leaking well. The well was no longer functioning during the October site visit and the delineated wetland area was dry. The entire abandoned ditch, and particularly the north end, was investigated for any culverts, conveyances or connections to other drainage or ditch features that could potentially flow into Beer Creek, the nearest natural channel, and none were found. Corps has determined that the 0.15-acre feature identified as 'D' on the delineation maps is an intrastate, isolated wetland with no apparent interstate or foreign commerce connection and, as such, is not currently regulated under CWA Section 404.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This drainage likely conveys irrigation tail water, storm water and ground water from areas to the north. Based on observations by Corps personnel during all seasons, the open channel contains year-round or near year-round flow. The ditch has been excavated 5-6 feet deep, which is at or near the water table. This drainage flows south and then parallels Arrowhead Trail Road southwest toward Beer Creek.
