C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Peavine Wash, a feature with perennial flow, is the main drainage for the southern portion of the study area, which flows into Ferron Creek approximately 2.5 straight-line miles east of the study area. An unnamed channel just north of the study area, also with perennial flow, drains into Rock Canyon Creek, which flows into Cottonwood Creek approximately 4.3 straight-line miles northeast of the study area. Cottonwood Creek and Ferron Creek drain into the San Rafael River, a tributary to the Green River. The Green River is the nearest TNW and its confluence with the San Rafael River is approximately 55 straight-line miles southeast of the study area.

Wetlands A-1, A-2, A-3, and A-4 are located within Peavine Wash and Wetlands B, D, E, F, G, H, P, and Q are directly abutting segments of Peavine Wash. Wetlands J and V are part of a larger wetland swale that flows down gradient and directly abuts Peavine Wash outside the study area. Wetlands M, N, and O are wetland drainages that flow north east and combine off-site to create the unnamed channel north of the study area. The wetlands listed above are currently regulated by the Corps since they are wetlands directly abutting a RPW that flow directly or indirectly into a TNW.

Pond 2 (0.16 acre) is the result of a berm placed across the wetland drainage area that consists of Wetlands N and O. The berm holds water back to form a small open water pond and a culvert installed in the berms conveys flow from Wetland N down gradient into Wetland O. The drainage continues off site into the unnamed channel with a surface connection to the Green River, the nearest TNW.
