Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The 0.015-acre feature identified as Wetland A is an abandoned stock pond constructed in an upland drainage swale. The pond receives drainage from an adjacent agricultural field to the south, though hydrology is infrequent and only creates saturated conditions in the pond for a brief period during the growing

season. Wetland characteristics have developed within the feature bottom. The Corps has determined that this abandoned stock pond was constructed in uplands and is not regulated at this time.

The 974-foot irrigation ditch running northeast to southwest through the study area receives flow from Big Hollow Ditch and is controlled by a diversion structure on the northeast side of the study area. The ditch was constructed in uplands and carries flow to adjacent fields west of the study area. The ditch and all conveyed flows terminate in these upland agricultural fields, with no connection to any other aquatic feature. The ditch is shut off and runs dry during much of the year. The ditch is was not constructed in a tributary, is not a relocated tributary, and does not drain wetlands. The Corps has determined the irrigation ditch no be a non-jurisdictional feature.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The data for the report were gathered during a time of year when the irrigation ditch did not exhibit OHWM. Corps staff visited the site during the growing season and observed OHWM characteristics. This was communicated to the consultant and the map was revised. Indicators consisted of staining, standing water, change in vegetation, absence of vegetation, rack lines.
