**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** As verified during the September 9, 2011 and June 20, 2019 site visits by Corps personnel, the 0.01-acre wetland within the property does not have a hydrologic connection with the nearest RPW, Provo River. This is further supported by historic aerial photographs and the depressional topographical break of almost 8 feet. There are no identifiable interstate commerce connections to the onsite wetlands. This feature was evaluated in 2011, coordinated with EPA, and determined to be non-jurisdictional due to isolation. No change has taken place since that time, though the acreage error from the previous determination was corrected from 0.05 acre to 0.01 acre.
