Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The 3.23-acre study area consists primarily of a man-made detention basin that was constructed in the mid-1990s to store surface runoff from a freeway re-configuration and surrounding development. The site has undergone substantial disturbance over the years, being part of a landfill for a time and then part of a golf course before its current use as a detention basin. Due to the depth of the excavated basin, water is generally

present year-round allowing wetlands (2.1 acres) to develop. When water level rises, it discharges to the south through a control structure and eventually into Utah Lake. The aquatic feature on site meets the definition of a "preamble water" since it's an artificial detention basin, created by excavating dry land to collect and retain water and which is used exclusively for settling sediments. Therefore, this feature is not currently regulated by the Corps.

#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
