This letter conveys Reclamation District No. 348, New Hope Tract's intent to participate in feasibility studies and/or other actions in the development of New Hope Tract Levee Improvements as the non-Federal sponsor consistent with the CALFED Bay-Delta Authorization Act (Public Law 108-361).

Reclamation District No. 348 understands that the type, cost, and scope of actions will be determined and specified later if selected for development and/or implementation pursuant to the Act. Reclamation District No. 348 also understands that if our project is approved for implementation, we will be responsible for sharing the cost of planning, designing, and implementation of the project with the U. S. Army Corps of Engineers; providing all necessary lands, easements, rights-of-way, relocations, excluding railroads, and suitable borrow and dredged or excavated material disposal areas; and accomplishing operation, maintenance, repair, replacement and rehabilitation of the project.

Please note that this letter of intent is not an obligation of funds. We look forward to working with the U. S. Army Corps of Engineers, the State of California, and other pertinent CALFED agencies and stakeholders on this important project.
