On February 09, 2022, our office received your Freedom of Information Act (FOIA) request for copies of all correspondence relating to SPK-202100131, Four Bridges Project.

For the purpose of assessing fees, I have classified you as a commercial requester under 32 C.F.R. § 286.12(b)(1). We waived the charges since we have failed to meet the 20-business day deadline.

A copy of the redacted correspondence relating to SPK-202100131, Four Bridges Project is enclosed. Although a majority of the information requested has been provided, names of Department of Defense (DoD) employees contained in the headers of e-mails and other similar lists of names within the records have been redacted pursuant to 5 U.S.C. §§ 552(b)(3),(6) of the FOIA. These provisions, known as Exemptions 3 and 6, exempt from disclosure any information specifically exempted from disclosure by statute, along with personnel and medical files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy. Pursuant to 10 U.S.C. § 130b(a), personally identifying information may be withheld from disclosure regarding any member of the armed forces assigned to an overseas unit, a sensitive unit, or a routinely deployable unit. See also <u>Hall v.</u> <u>C.I.A.</u>, 881 F. Supp. 2d 38, 66 (D.D.C. 2012); Dep't of Defense, Manual 5400.07 ¶ 5.2(c)(2)(a) (Jan. 25, 2017).

Secondly, emails containing attorney-client communication are exempt from release pursuant to the protection afforded to them under 5 U.S.C. § 552 (b)(5), generally known as "Exception 5" of FOIA. Specifically, emails are protected from disclosure under the attorneyclient and attorney work product privileges as incorporated into Exemption 5. These privileges afford sweeping protection to factual materials as well as opinions generated by the United States Army Corps of Engineers (Corps) legal counsel. *See e.g.*, <u>United States v. 

Specifically, the following Special Conditions have not been met:

Special Condition No. 1: To ensure your project complies with the Federal Endangered Species Act, you must implement all of the mitigating measures proposed as part of your project description, which are identified in the enclosed U.S. Fish and Wildlife Service letter of concurrence (Number FWS #08ESMF00-2020-I-0470-R001, dated May 4, 2020) and National Marine Fisheries Service letter of concurrence (Number NMFS # WCRO-2020 00307, dated April 9, 2020). 





The BO from USFWS does state you will compensate for the effects to 0.145 acre of fairy shrimp and tadpole shrimp habitat at a ratio of 3:1 with 0.435 acre of preserved lands located in Beale AFB's on-site designated vernal pool preservation area. This is compensatory mitigation for USFWS and the Corps is not involved in this as the BO is issued to you. We do incorporate the BO as a special condition to show section 7 compliance. That is great to hear about funding for AMR. We will look at that for our mitigation ratio checklist. I would not recommend buying until you know what would be required based off of the mitigation ratio checklist. In order to go through the mitigation ratio checklist I will need to know what you would like to buy from AMR (e.g vernal pool, seasonal wetland/creation enhanced) What is the status of the 401 WQC?

On another note, what is the status of purchasing credits for the four bridges. If this is not purchased soon, the Corps may need to increase the mitigation for the increase time of temporal loss. Thank you very much for your time.

I am responding to your email below sent to my gmail account while I was on leave.

Thank you for re-opening the request for a NWP Permit 39. As you know, this is a mission critical project for Beale AFB with tight timelines. Beale AFB is planning on purchasing mitigation credits as discussed with your office for 0.64 acres (0.32 acres at 2:1 to compensate for temporal loss) from Antonio Mountain Ranch Mitigation Bank (AMR). After multiple inquires, I just received a response from AMR to proceed with my request. I've been informed that Beale AFB has identified funding for the mitigation and the acquisition can proceed as soon as we receive the invoice and payment direction from AMR.

To address your question regarding the BO, the USFWS mitigation can be accomplished on Beale as we have been doing mitigation on Base for more than 20 years now with both USACE and USFWS. This was agreed upon through the signing of the Integrated Natural Resource Management Plan (INRMP) every 5 years and the SAMP process started in the early 2000s. This mitigation was not set up in perpetuity with official documents but was an MOA; see attached. This method of mitigation is actually preferred by USFWS.

Good Morning (b) (6),

I regret to inform you of additional issues that occurred with this project Monday. Please see attached photos of the area of concern. Please advise on removal or improvement of this temporary structure. I have included the natural resources manager in this email because she performs the consultation with NMFS.

I first received notice of the activity late Monday via a texted photo from one of our biological monitors. The contractor placed gravel fill in Dry Creek Overflow that is partially de-watered in order to retrieve vehicles stranded since the large precipitation event October 23-25. In the weekly meeting with the contractor Tuesday morning I explained that this was a violation because the fill was placed without authorization or consultation with USACE and NMFS, they did not inform or consult with environmental, rain was forecast, and that a fish monitor was not present. I was later able to confirm that a fish monitor was not present. While we did not want the vehicles to remain there for the entire winter because they are a potential source of contaminants, I had already outlined a process that needed to be followed for unauthorized activities. I was informed that they decided to install this crossing because they felt that the benefits outweighed the risk. They also believe that they implemented BMP that caused no damage, and therefore made it ok.

Based on the report from the biological monitor and the attached photos he provided, there appears to be turbidity resulting from this operation. I again reiterated the process they must follow for approval of any activities outside of what has been approved. This was also reiterated to Beale's Project Manager whom I have mentioned to you. I have followed up with my immediate chain of command and the Project Manager's supervisor and have scheduled a meeting this afternoon to prevent events such as these in the future.

The biological monitor provided the following information about the site.

Approximately 13 feet wide, 30 feet long with large cobble type rock. One foot thick at its center and tapering out. Thick fabric laid along streambed under the rock. Sedimentation was evident downstream, and increased heavily when the monitor unintentionally disturbed

the upturned fabric damming the water on the upstream side. The only cause for this was stepping on the upturned fabric on the upstream side, by the monitor. Not intentional, not typical of how the site looks. Dam on dry creek overflow. Majority of water flow is coming around the eroded streamside. Large fish were noted in the construction site of Dry Creek.

Please contact me with any additional comments or recommendations. As I mentioned above, I assume you want this removed or at a minimum improved (if deemed necessary for winterization). I do not know if the contractor is using this route for access to remove falsework or plans to use for other activities. I was made aware yesterday that they intend to install RSP on this bridge. I explained that we do not have authorization for installing fill. Their response was that this was part of winterization and already approved under the permit. I reminded them that we do not have a valid permit and that if the fill placement is need for stabilization, they must provide a detail explanation of the activity including placement and fill volume and why it is necessary for stabilization so that we can consult with NMFS and USACE.

We did have the monitor take measurements of the coffer dams and make additional observations around the coffer dams to assist NMFS with making a determination if leaving the lower blocks of the coffer dams will be a fish barrier because the contractor has requested to leave them in. We will be providing that information later today.

I first received notice of the activity late Monday via a texted photo from one of our biological monitors. The contractor placed gravel fill in Dry Creek Overflow that is partially de-watered in order to retrieve vehicles stranded since the large precipitation event October 23-25. In the weekly meeting with the contractor Tuesday morning I explained that this was a violation because the fill was placed without authorization or consultation with USACE and NMFS, they did not inform or consult with environmental, rain was forecast, and that a fish monitor was not present. I was later able to confirm that a fish monitor was not present. While we did not want the vehicles to remain there for the entire winter because they are a potential source of contaminants, I had already outlined a process that needed to be followed for unauthorized activities. I was informed that they decided to install this crossing because they felt that the benefits outweighed the risk. They also believe that they implemented BMP that caused no damage, and therefore made it ok.

Based on the report from the biological monitor and the attached photos he provided, there appears to be turbidity resulting from this operation. I again reiterated the process they must follow for approval of any activities outside of what has been approved. This was also reiterated to Beale's Project Manager whom I have mentioned to you. I have followed up with my immediate chain of command and the Project Manager's supervisor and have scheduled a meeting this afternoon to prevent events such as these in the future.

The biological monitor provided the following information about the site.

Approximately 13 feet wide, 30 feet long with large cobble type rock. One foot thick at its center and tapering out. Thick fabric laid along streambed under the rock. Sedimentation was evident downstream, and increased heavily when the monitor unintentionally disturbed the upturned fabric damming the water on the upstream side. The only cause for this was stepping on the upturned fabric on the upstream side, by the monitor. Not intentional, not typical of how the site looks. Dam on dry creek overflow. Majority of water flow is coming around the eroded streamside. Large fish were noted in the construction site of Dry Creek.

Please contact me with any additional comments or recommendations. As I mentioned above, I assume you want this removed or at a minimum improved (if deemed necessary for winterization). I do not know if the contractor is using this route for access to remove falsework or plans to use for other activities. I was made aware yesterday that they intend to install RSP on this bridge. I explained that we do not have authorization for installing fill. Their response was that this was part of winterization and already approved under the permit. Hi(b)(6),

I am assuming you mean infill for the crossing. The contractor did this without my knowledge and I gave them feedback the next morning that they need to follow the process for authorization. The best information I have is the crossing is approximately 13 feet wide depth of rock is 12 inches, at the center and 6 - 8 inches at the edges. The length of the span through the creek is estimated at 30 feet. I am pretty certain the fill was placed on Monday, the 8th, but may have happened earlier. I learned about it at the end of day on the 8th. The photos were taken on the 8th.

Regarding the vehicles that were stranded, the contractor built the access road to remove them. They should have not left in the interim construction site before the storm. There may be photos of the vehicles in the pdf file I provided via DOD Safe after the large storm. Environmental had explained that they need authorization for any vehicles accessing the Creek and emphasized that this was a requirement of both NMFS and USACE. We were waiting for the request so that we could present it to consulting agencies. The contractor informed me during the meeting when I reiterated this information that they felt the benefit outweighed the risk. As those vehicles are not now stranded, we aren't doing anything about it.

I would like them to remove the access road as it is an issue for a variety of reasons. I do not have the authority to do that unless directed by NFMS or USACE. I cannot request it because I am not designated as a COR and within that, I do not have the authority to direct them in a way that could result in them claiming additional expenses for the convenience of the government.

The contractor is requesting authorization to install RSP above the OHWM that will provide important slope stabilization, especially for high flows. Equipment access in the channel will not be required. Neal, this work is not regulated by USACE per my conversation with (b) (6) last week, but it does fall within NMFS's area of jurisdiction. 

Please see the attached email regarding turbidity exceedance on Dry Creek resulting from removal of diversion pipes. Earlier today, removal of the diversion pipes from the 3114 channel caused a temporary spike in turbidity at the established monitoring station approx. 300 ft below the bridge. Background turbidity of 1.4 NTUs spiked to 4.0 NTUs, but returned to background within 90 minutes of the disturbance.

Falsework has been removed from Bridge 3114 on Dry Creek. Attached photos show current status of the site.

The best information I have is the crossing is approximately 13 feet wide depth of rock is 12 inches, at the center and 6 - 8 inches at the edges. The length of the span through the creek is estimated at 30 feet. I am pretty certain the fill was placed on Monday, the 8^{th} , but may have happened earlier. I learned about it at the end of day on the 8^{th} . The photos were taken on the 8^{th} .

Regarding the vehicles that were stranded, the contractor built the access road to remove them. They should have not left in the interim construction site before the storm. There may be photos of the vehicles in the pdf file I provided via DOD Safe after the large storm. Environmental had explained that they need authorization for any vehicles accessing the Creek and emphasized that this was a requirement of both NMFS and USACE. We were waiting for the request so that we could present it to consulting agencies. The contractor informed me during the meeting when I reiterated this information that they felt the benefit outweighed the risk. As those vehicles are not now stranded, we aren't doing anything about it.

I would like them to remove the access road as it is an issue for a variety of reasons. I do not have the authority to do that unless directed by NFMS or USACE. I cannot request it because I am not designated as a COR and within that, I do not have the authority to direct them in a way that could result in them claiming additional expenses for the convenience of the government.

I regret to inform you of additional issues that occurred with this project Monday. Please see attached photos of the area of concern. Please advise on removal or improvement of this temporary structure. I have included the natural resources manager in this email because she performs the consultation with NMFS.

I first received notice of the activity late Monday via a texted photo from one of our biological monitors. The contractor placed gravel fill in Dry Creek Overflow that is partially de-watered in order to retrieve vehicles stranded since the large precipitation event October 23-25. In the weekly meeting with the contractor Tuesday morning I explained that this was a violation because the fill was placed without authorization or consultation with USACE and NMFS, they did not inform or consult with environmental, rain was forecast, and that a fish monitor was not present. I was later able to confirm that a fish monitor was not present. While we did not want the vehicles to remain there for the entire winter because they are a potential source of contaminants, I had already outlined a process that needed to be followed for unauthorized activities. I was informed that they decided to install this crossing because they felt that the benefits outweighed the risk. They also believe that they implemented BMP that caused no damage, and therefore made it ok.

Based on the report from the biological monitor and the attached photos he provided, there appears to be turbidity resulting from this operation. I again reiterated the process they must follow for approval of any activities outside of what has been approved. This was also reiterated to Beale's Project Manager whom I have mentioned to you. I have followed up with my immediate chain of command and the Project Manager's supervisor and have scheduled a meeting this afternoon to prevent events such as these in the future.

The biological monitor provided the following information about the site.

Approximately 13 feet wide, 30 feet long with large cobble type rock. One foot thick at its center and tapering out. Thick fabric laid along streambed under the rock. Sedimentation was evident downstream, and increased heavily when the monitor unintentionally disturbed the upturned fabric damming the water on the upstream side. The only cause for this was stepping on the upturned fabric on the upstream side, by the monitor. Not intentional, not typical of how the site looks. Dam on dry creek overflow. All,

As I mentioned earlier, there were issues that surfaced because of increased flow. Beale had informed the contractor the flows would increase and that larger pumps were needed multiple times. The coffer dam on Best Slough was not strong enough and was at risk of failure. The design of the project has not changed, just the dewatering in Best Slough although we are informing the contractor that their other structures are at risk without more vigorous pumping. In addition to the rebuilt coffer dam, diversion pipes are being placed to divert water from above the coffer dam

below the project site as was done on Dry Creek. The diversion pipes in Dry Creek were included in the permit.

Here is the guidance from NMFS Service: Thank you for discussing the needed changes at the construction site to account for increased flows, Tamara. Based on our discussion, a stronger temporary barrier (coffer dam) will need to be installed to prevent the higher flows from entering the construction area. Similarly to the original description of the Proposed Action, flows will continue to be routed around the construction site using culverts and will re-enter the creek below the construction area. This minor adjustment to account for increased flows is not expected to change the expected effects of the Proposed Action that were considered as part of the Letter of Concurrence for the project. As discussed, a qualified fish biologist will be on-site in the coming days to assess fish presence.

I need to provide you an update on this Project. I was called in this last weekend to address issues on this project. Water in Dry Creek came up substantially because of a sudden change in water use by upstream land owners. Although previously warned multiple times, the contractor was not prepared for the increased flow. One of the coffer dams was at risk of failure and was leaking substantially. To reduce flooding in the construction area that was happening we notched a downstream beaver dam. We have reached a path forward with the contractor for proper de-watering of the channels and have received agreement from NMFS. I believe this may require an update to the 401 and 404 permits. I will be able to provide full details of the proposed changes either later today or tomorrow. I am not sure of the process and all of the information you will need.

In order for me to ensure compliance with Section 106 under Section 404 of the CWA, I need to review the information that was submitted to SHPO otherwise I won't be able to move forward with the permitting process.

Also, we are going to have to do compensatory mitigation for this project because of total amount of permanent impacts. What I'm thinking is doing either three or four NWP 14's, either one for each bridge, or one for Bridge 3111, one for 3112, and then one for both 3113 and 3114. For Bridge 3111 across Best Slough Overflow, the total permanent impacts are going to be 0.05 acre so that won't need mitigation. However, for Bridge 3112, the total permanent impacts are going to be 0.18 acre. For Bridge 3113, the total permanent impacts are going to be 0.16 acre. And for Bridge 3114, the total impacts are going to be 0.16 acre. Bridges 3112 through 3114 will need compensatory mitigation since they will have a permanent loss of waters due to the RSP placement. I think that doing an in-lieu fee program would be the quickest way to move forward. To move forward, I am going to need a mitigation plan describing how the mitigation requirement will be satisfied.


