



# American River Common Features 2016 Construction Update

April 2022

## Highlights (last 30 days)

### Sacramento River East Levee (SREL)

During the month of March, we continued jet grout quality control near Broadway for our 2021 construction effort, awarded our first construction contract to address flood risk associated with erosion, and began mobilization for our 2022 construction effort to include fencing and vibration monitor installation, conducting pre-construction surveys and other miscellaneous site prep activities for construction to begin in April 2022.

## Looking Ahead (next 30+ days)

### Current Activity Update - What can I expect?

Monday – Saturday 7am-6pm

**Big Pocket:** Our 2021 construction is wrapping up and our 2022 construction is rolling out. You will see material and equipment delivery at Zacharias Park, batch plant mobilization at the Pocket Canal, truck traffic through Garcia Bend, removal of encroachments, levee degrade in the center of the Big Pocket with the construction of the first cutoff wall at the most southern end near the Pocket Canal.

**Broadway:** Levee Reconstruction and bike path paving will continue near Broadway. Bike Path closures will remain in place for remaining work. We ask that everybody please be respectful and stay clear of construction work zones as established by construction fencing and signage. Sacramento Police Department will continue having an on-site presence during construction, so you can expect to see an officer parked on or near the jobsite.

A virtual public meeting for our second erosion contract is scheduled for April 26 at 4:30 p.m.



A new encroachment permit must be submitted through the Central Valley Flood Protection Board.
