Highlights (last 30 days)

Sacramento River East Levee Contract 1 Construction Activity

Construction activities fully underway and making great progress! Continued material/equipment delivery, batch plant operations, and installation of a berm and five segments of cutoff wall—including one completion north of Sutterville Rd!

Looking Ahead (next 30+ days)

Construction Update - What can I expect?

Construction activity to continue aggressively to get the levee improvements in place within a short window outside of the flood season. Construction is taking place in very limited space and within close proximity to homes. You will notice large construction equipment, significant truck traffic, there will be increased dust and noise in the area and the bicycle path will be closed throughout construction. Working Hours: Monday– Saturday 7am-7pm, with quiet work extending until 8pm.

Freeport Regional Water Facility Staging

- ◆ 50-70 trucks/per day for levee backfill
- ◆ Typical office traffic

Garcia Bend Park Staging

- ◆ Slurry pond and batch plant operations
- ◆ Bentonite and cement deliveries daily

Big Pocket

- ◆ Cutoff wall construction continues—four locations
- ◆ Sump 132 DMM batch plant
- ◆ 1-2 trucks/day
- ◆ Begin levee rebuild—50-70 trucks daily entering at Freeport yard

Little Pocket

- ◆ Deep cutoff wall continues—reduction to one rig
- ◆ Erosion repair continues
- ◆ 1-2 trucks/day
- ◆ Begin levee rebuild 40-50 trucks/day

Sutterville

- ◆ Bike paving, striping, and hydroseeding

Miller Park

- ◆ Continued construction of seepage berm
- ◆ Parking stalls will remain open Saturday and Sunday.
