Summarize overall biological, chemical and physical functions being performed: Wetland areas at this site may filter runoff from the roadway to the east of the wetlands. They may also filter pollutants from the nearby agricultural developments prior to the water entering the drainage ditch and ultimately to the Great Salt Lake, via the Malad and Bear Rivers. Potential pollutants from these areas may include fertilizers and pesticides.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: W-4 is a wetland complex of 4 separate depressional wetlands that are interconnected by an upland swale that parallels the eastern side of the railroad tracks on the east border of the project site. Water flows south through the wetland areas and through the upland swale to a roadside ditch southeast of the property. The ditch is a perennial RPW that flows into the Malad River, which flows to the Bear River, which flows into the Great Salt Lake, a traditionally navigable water. The wetland areas may serve to filter pollutants, including pesticides and fertilizers from nearby agricultural development, from water flowing to the roadside ditch.

Wetland 3, located on the west side of the railroad tracks, directly abuts the perennial roadside ditch along the southern property boundary and is therefore a jurisdictional water. The canal that bisects the property was determined to be a jurisdictional water because it takes water from the Bear River and discharges back into the Bear River, which is a water of the US. The wetlands located in the south-central portion of the property are tentatively determined to be isolated and non-jurisdictional. This determination is currently being coordinated under separate cover.




Figure 1. Project Location.




Figure 5. Wetland delineation results.
