W-3 is a saltgrass dominated, depressional wetland located immediately west of rail road tracks. W-3 is direct abutting a roadside ditch southeast of the project site that is a perennial relatively permanent water. The roadside ditch flows into the Malad River which flows into the Great Salt Lake, a traditionally navigable water.




Figure 1. Project Location.




Figure 5. Wetland delineation results.
