B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

2. Characteristics of wetlands adjacent to non-TNW that flow directly or indirectly into TNW

(a) General Wetland Characteristics:

Characteristics: Connection to FW-1 and ED-1 appears to be through an upland swale. Weak flow indicators (weak discontinuous wrack line and oriented vegetation) indicate water flows through the swale. Area is heavily vegetated, so continuous indicators were hard to observe.

(c) Wetland Adjacency Determination with Non-TNW:

Discrete wetland hydrologic connection. Explain: Connection to FW-1 and ED-1 appears to be through an upland swale. Weak flow indicators (weak discontinuous wrack line and oriented vegetation) indicate water flows through the swale.

Ecological connection. Explain: The Seasonal Wetland, FW-1 and ED-1 occur within a zone of riparian vegetation (willow, cottonwood, etc.), so it is likely that species move back and forth between the waters.

Summarize overall biological, chemical and physical functions being performed: Wetlands retain stormwater and filter and provide sink for pollutants in runoff from Penryn Road, Boulder Creek Road, and Interstate 80. Wetlands also provide habitat for species with a riparian plant community.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
