C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

There is no discernable effect from this wetland on the Blue River, since there is no surface connection to the Blue River. Sbsurface connection if any, would be 900 feet distant, and the effect of this 0.05 acre wetland area on the Blue River is speculative and insignificant at best .**

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland E on the subject parcel is the remnant of an old irrigation ditch which no longer has surface connection to any other body of water. The source of water previously, was Willow Creek, and the irrigated area previously is now an elementary school. The irrigation water rights have been transferred, and the headgate from Willow Creek is permanently shut. The only remaining source of hydrology could be precipitation, snowmelt, and possibly groundwater at the bottom of the ditch. The vegetation in this north portion of the parcel has been observed to be stressed and diminishing in size and quality..
