These are natural impoundments and lower spots along an apparently non-jurisdictional swale which is a tributary to a tributary to Cosgrove Creek which is approximately 600 feet northeast of the project site and a tributary to the Calaveras and San Joaquin Rivers which are navigable. There are also wetlands characterized by cottonwoods and eleocharis in the NAPOTS, but these are in an area associated with recent (~2-3 years old)

earth moving disturbance and construction of a detention/retention basin with elevated concrete standpipe-type outfall structures.
