C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

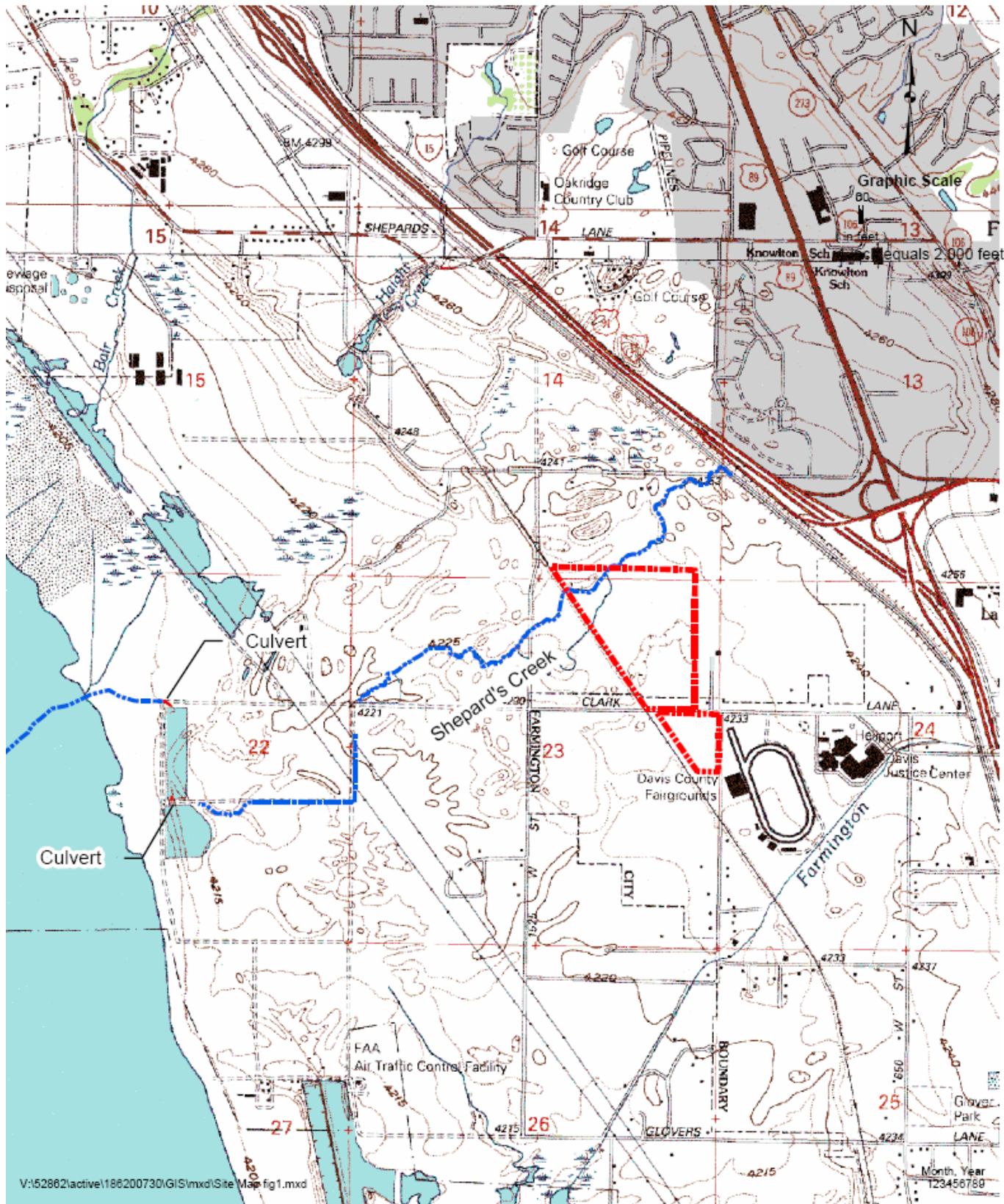

B. ADDITIONAL COMMENTS TO SUPPORT JD: Water flows into the project site from the north through Shepard's Creek, a perennial RPW. Water then sheetflows into wetland areas A and B, depicted on the attached wetland delineation map. Both wetland zones are characterized by emergent marsh and wet meadow wetland types totaling 2.84 acres. Water then flows out of the project site through a culver under an existing railroad grade to the Great Salt Lake, the closest TNW.

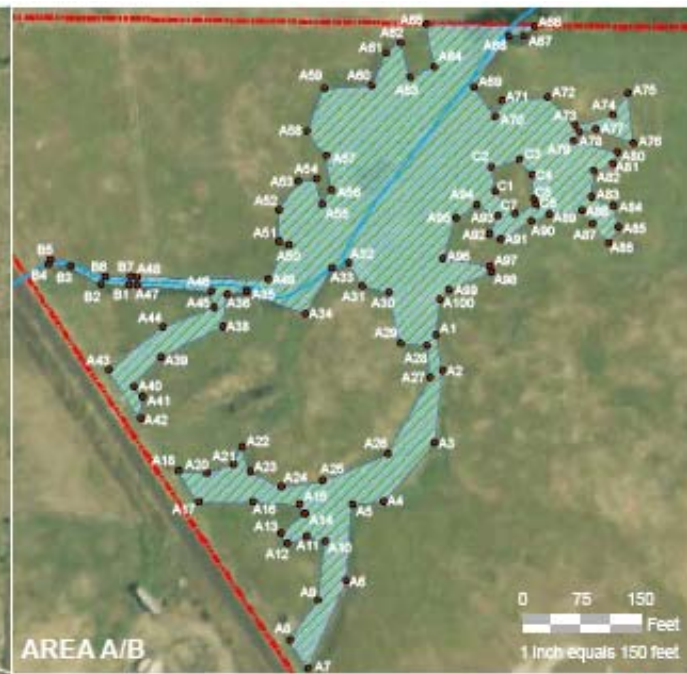

Site Location Map







