C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The consultant for Pine Meadows concluded that water from her site entered the storm drain system on the north side of Highway 49 and discharged into Olympic Creek on the south side of Highway 49, south of the commercial development. This was confirmed through aerial photography by Erin Hess.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Erin Gottschalk, North Fork Associates, included in the wetland delineation report that the ditch was not jurisdictional because it was a daylighted portion of the Grass Valley storm drain system and that it did not contribute significant mineral or organic matter to a downstream navigable water of the U.S. However, after reviewing a historic topographic map, it was found that Olympic Creek historically flowed near the ditch's current location. During the Corps' site visit, it was found that upstream portions of Olympic Creek and other unnamed tributaries entered the storm drain system on the north side of Highway 49. Additional daylighted portions of the storm drain system were found between developments adjacent to the north side of Highway 49 and the Highway's southbound off-ramp (upstream of the project location), between Brunswick Road and developments south of Brunswick Road (downstream of the project location), and between the developments south of Brunswick Road and Plaza Drive (downstream of the project location). A culvert was observed beneath Plaza Drive connection the storm drain system to Olympic Creek. Olympic Creek's natural channel began on the south side of Plaza Drive. It was therefore determined that Olympic Creek has been rerouted through the Grass Valley storm drain system beneath Highway 49 and beneath the developments north and south of Highway 49.
