The river from Lake City downstream is used for whitewater recreation and for fishing from south of Lake City to the BLM campground at Red Bridge. There is also fishing in the Lake Fork arm of Blue Mesa Reservoir. There are several put ins for whitewater activities in Lake City, five miles north and at 2 BLM sites. Rafting trips are advertized for both the upper and lower Lake Fork on the Colorado Rafting Association website.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

SUBJECT: Traditional Navigable Water; Navigable In Fact Determination for the Lake Fork of the Gunnison River SPK-2008-29-GB

1. The Corps completed a review of the Uncompander River from Lake San Cristobal, upstream from Lake City, Colorado, to its confluence with the Gunnison River at Blue Mesa Reservoir, near Sapinero (approximately 35 miles) with the intent of completing a determination regarding its navigability.

2. This Determination is made in accordance with Appendix D of the Rapanos Guidance.

3. The Lake Fork is a popular for fishing and whitewater floating/kayaking activities. Lake San Cristobal has boats for rent along with shoreline fishing and camping. There are numerous public access locations for fishing and boating. Eight locations are noted as public

access fishing spots on the Colorado Directory's Lake Fork Gunnison River Fishing Map on the web. Eddy Flower's kayak website describes four reaches along the river with put in and take out locations. The BLM has two campgrounds with river access and the Colorado Rafting Association advertises two different rafting trips on the Lake Fork. The lower five miles of the river is within the high water line of Blue Mesa Reservoir which is part of the Curecanti National Recreation Area and is popular for boating, fishing and other water based recreation.
