C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

There is a potential for federally listed vernal pool species to occur within the vernal pools. However, because there are very few vernal pools on-site, and they are of low quality, this too, would not provide any significance..

B. ADDITIONAL COMMENTS TO SUPPORT JD: Two site visits were conducted to verify the isolation/no significant call nexus for the subject property. The aerial photo appears to show signatures on portions of the site which were not themselves wetlands but could have provided a hydrologic connection or that had potential to be wetlands themselves or transport water to/from wetlands to the nearest stream. These areas look darker green on aerial photos that were shot later in the year (june-september). The first site visit was during the driest period of the year and even the mapped wetlands and Vernal pools had upland vegetation growing throughout. However, based on the drought conditions, the site was reassessed and confirmed that the mapped isolated wetlands did have hydric soils, vegetation, and hydrology to support a wetland determination. The site is comprised of two-three terraces that are flat until hitting a steep slope. Each level is approximately 5-10 drop. The toe of the slopes show up as the darker areas mentioned above and were different shades of green. This was due to the timing of the aerial photo and what vegetation was occurring and still growing there this time of year. Yellow star thistle (upland plant spp.) dominates these areas and soils were no where near hydric and did not have any hydric indicators. It's growing season allows it to stay green through a majority of summer. It had rained most of the night before the second site visit and no hydrology, plants or soils were evident in every suspect area on-site. It was determined that these areas could not transport water or nutrients from the wetlands that did meet wetland criteria. The only surface water was found in both the ponds and V2 Vernal Pool. Topographic relief on-site would not allow for any overland sheet flow to carry water from these on-site features to the nearest stream (between 600 and 1200 feet away from the mapped features). Little to no subsurface flow occurs on-site and if present, would not occur for the distance needed to reach any tributaries.

Elder Creek is 15-25 feet below the mapped features. There is no swales or tributaries that slope north toward Elder Creek. It was also determined that the wetlands on-site having no hydrologic connection to any waters of the U.S. also did not have a significant nexus with the nearest TNW or have an interstate commerce connection. The land is used for a small cattle operation in which the free ranging cattle may occasionally use the wetlands for the short duration they might possess water. There is no evidence to support that these wetlands could have anymore than a speculative level of significance needed for a significant nexus determination.
