C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The study area is located at the northern tip of Liberty Island and is bounded on the east by Liberty Cut and bounded on the north and west by Shag Slough. Both Shag Slough and Liberty Cut are listed by the Sacramento District as navigable waters of the US for purposes of administering navigation laws. All of the wetlands within the study area are adjacent to either Shag Slough or Liberty Cut. The NRCS' Yolo County Soil Survey states that Liberty Island is flooded on regular basis averaging one year in every three. Although levees exist on Liberty Island, they are breached in many locations so that during the frequent flood events the study area is entirely inundated. Therefore, all of the wetlands are adjacent to navigable waters and at times directly tributary or a part of those navigable waters.
