Explain: **A 1.42-acre wetland plant community was observed in an abandoned pond at the west end of the property.**

**The earthen dam for the pond was breached; however, the remains of the dam collect enough water to support a small wetland community. This community was separated from the identified jurisdictional wetland by upland grasslands with no defined bed and bank. Earthen dam and water impoundment was indicated on the 1964 Pagosa Springs,**

**USGS 7.5 minute quadrangle. No data was available to indicate when the dam was breached; however, vegetation stabilization of the breached basin indicates that it was likely greater than 5-10 years ago. The area has been reviewed in accordance with 33 CFR 328.3.(a)(3) and we have found that the use, degradation or destruction of the isolated waters would not affect interstate commerce .**

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). Summarize overall biological, chemical and physical functions being performed: Water that collects in the basin above the breached dam provides moisture for an isolated wetland community.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?

It is unlikely that this wetland community provides any habitat for fish and other aquatic species. Minimal amounts of litter and debris in the area. The feature is man-made and likely provides temporary impoundment prior to evaporation.

A brome grass swale exists between this wetland feature and the southern wetland feature. Due to its small size and the distance to the San Juan River, the wetland in question does not have significant nexus to a traditional navigable waterway.**

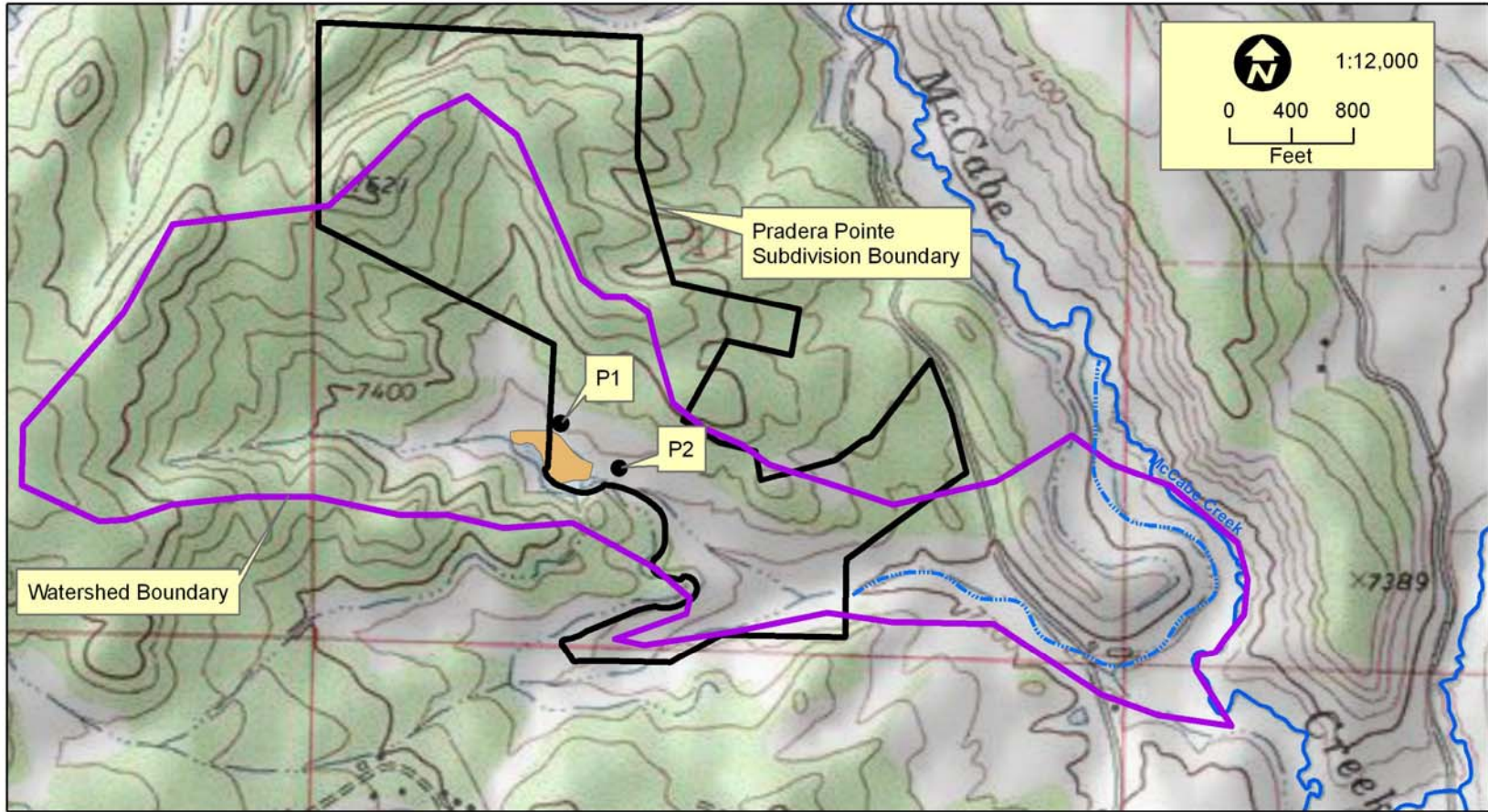

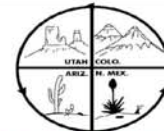
**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This determination is for a 1.47 acre wetland. There is little evidence that the wetland area flows to a waters of the U.S. A brome grass swale exists between this wetland feature and the southern wetland feature. Due to its small size and the distance to the San Juan River, the wetland in question does not have significant nexus to a traditional navigable waterway. The area has been reviewed in accordance with 33 CFR 328.3.(a)(3) and we have found that the use, degradation, or destruction of the isolated waters would not affect interstate commerce.

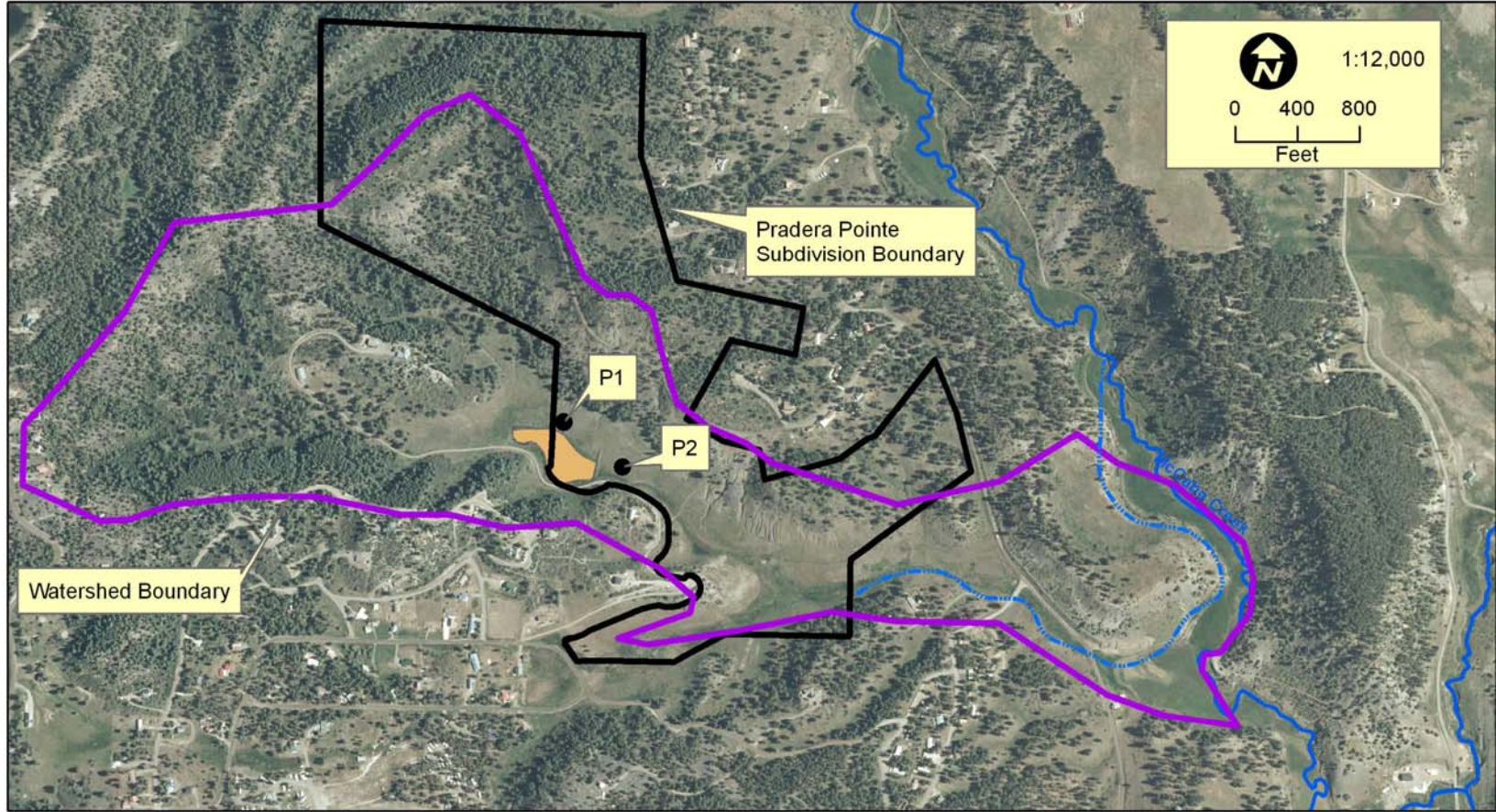

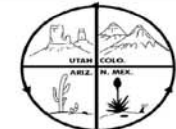
