This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

In addition, secondary hydrologic indicators include a positive FAC-Neutral test. Hydric soil indicators consist of low chroma color with mottling. Organic content was observed in all the soil samples. The wetland boundaries were clearly defined by change in vegetation from an arctic rush/sedge dominated wet meadow to upland vegetation consisting of smooth brome, slender wheatgrass, and Kentucky bluegrass and a transition to soils of higher chroma. Flow has been observed in the tributary continuous during the growing season.

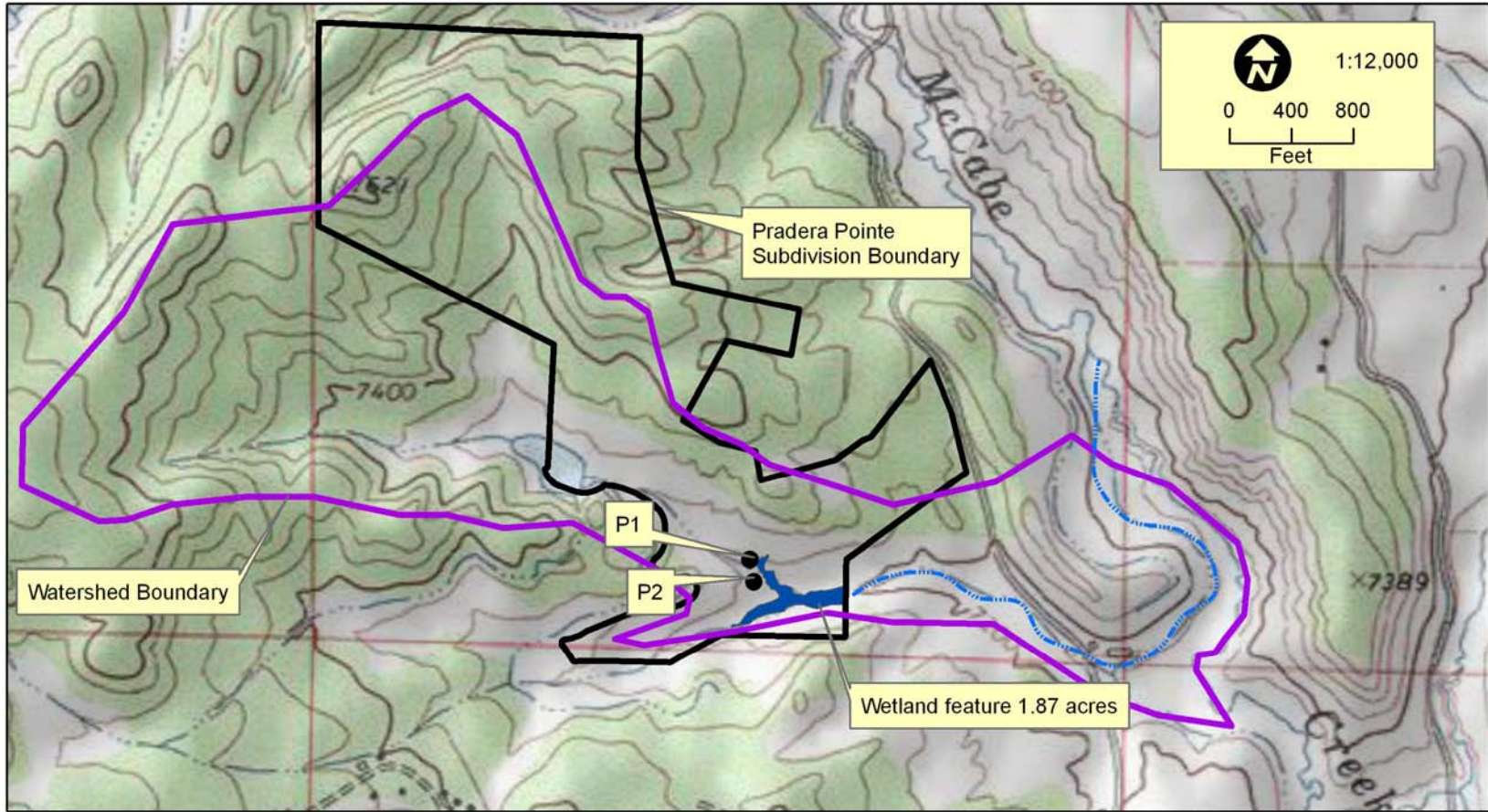

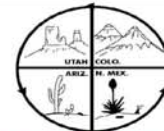




### Pradera Point Subdivision Jurisdictional Perennial Spring Wetland Watershed Map

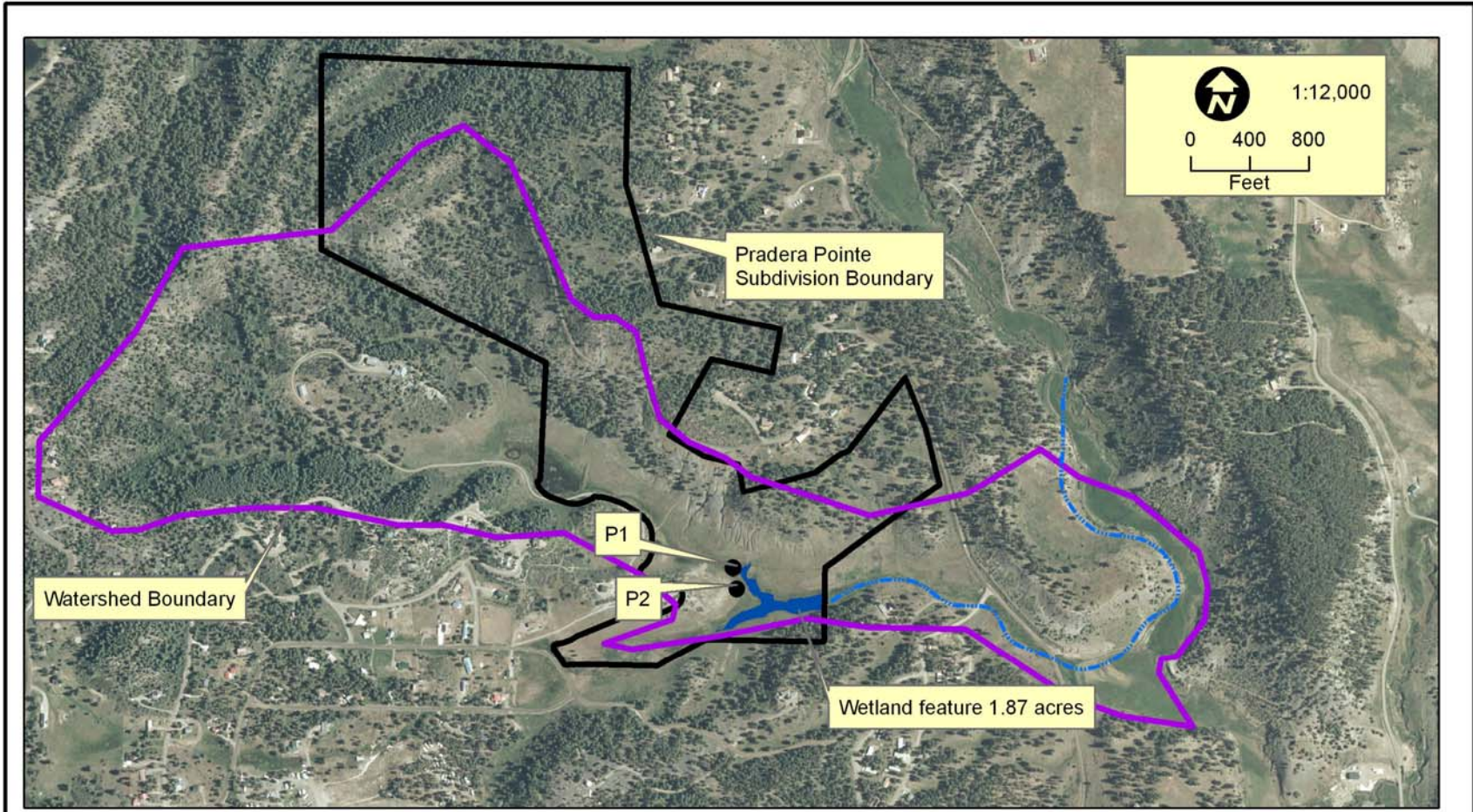

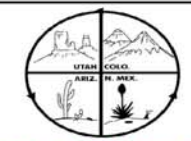
