C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.





B. ADDITIONAL COMMENTS TO SUPPORT JD: The segment of waters under jurisdictional examination extend from above an wetland complex at the intersection of 62nd Street and 22nd Street in Rio Linda, down to the confluence of an unnamed tributary to a tributary to the north reach of Rio Linda Creek. Waters from the wetland complex just north of the swale flow through the swale and into an unnamed tributary, which flows into the Rio Linda Creek, which flows into the Natomas East Main Drainage Canal, and then into the Sacramento River, a section 10/Traditionally Navigable Waterway. Multiple flow events per year have been observed by the property owners who state that water only flows through the tributary after prolonged periods of heavy rain and/or until the surrounding soil is saturated. Otherwise, the swale tributary it is dry most of the year. The increase of ruderal, private, and commercial development has adversely impacted the water quality of the creek and waters downstream through the filling of wetlands and resulting in loss of wetland water quality functions. This tributary and its associated wetlands serve to capture surface drainage from the surrounding area and contain the associated contaminants, contributing to improved water quality within the creek and waters downstream.
