Explain: As they occur today, the wetlands are situated in a small gully with a culvert under a dirt road connecting the two wetlands. The gully, down gradient of the wetlands was filled prior to the 1970's to create a farmstead, thereby severing the drainage pattern down the gully. These two wetlands are what remains of seven fishing ponds that were constructed and in operation during the 1970's and early 1980's as documented by aerial photographs, neighboring farmers, and NWI maps. During this time period, there was a spring feeding these ponds and the property owner, in an attempt to increase the spring flow, set-off sticks of dynamite which resulted in sealing the spring instead. The fishing pond venture ended and the ponds were filled with the exception of what remains of the two degraded wetlands.

The nearest flowing water in relation to these wetlands is a spring 800 feet to the southeast across 4850 West Street. No other connections, (e.g. abutting wetlands, pipes, shallow subsurface flow) make a hydrologic connection between these wetlands and other waters of the U.S. According to two local farmers, they have seen other local springs and seeps become dry as up-gradient land use practices have changed from irrigated agricultural to residential and commercial development. There the is no evidence of any interstate commerce connections associated with the project site as the land is fallow fields of the old farmstead that are no longer farmed.

C. SIGNIFICANT NEXUS DETERMINATION








Isolated wetland location






Plat B. South edge of north wetland looking north
