Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: An approximately 0.42-acre pond and five wetlands totaling 0.38 acre are located on the northwest end of the review area. These features are on an elevated plateau with berms and/or higher elevations on all sides. This entire portion of the site was subject to historic dredge mining activities. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity

of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The northwestern portion of the site is a plateau at a higher elevation than the rest of the site. There are no drainage features onsite that convey water from this plateau. The plateau is relatively flat with mounds of soil and rock, resulting from historic mining activities. All six features (one pond and five wetlands) have small drainage areas and appear to be mostly rain fed. The pond has elevated banks on all sides with the lowest portion at the northwest corner. There is a potential that the pond could overtop its banks and sheet flow into the field to the northwest of the review area. The field appeared to consist entirely of uplands and does not serve as a connection to other waters or aquatic features.
