Summarize overall biological, chemical and physical functions being performed: The wetlands considered cumulatively are only for this project site, Boulder Creek has many, many more. These onsite wetlands provide excellent high quality, benefits to the TNW through Boulder and Churn Creek. On-site there are submerged sub-surface wetlands, emergent wetland fringes, seasonal depressional wetlands, linear wetlands, etc. that all have different biota, nutrients, species using and thriving in them and ability to increase water quality and affect flood storage.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

This indicates it like was already dipping subsurface downstream and was not moving an extremely high amount of water through it. However, the fact that it did still have water easily supports that it would have for a period of three months straight through Dec.-March. It is a known intermittent stream that sustains rain for more than three months every year.

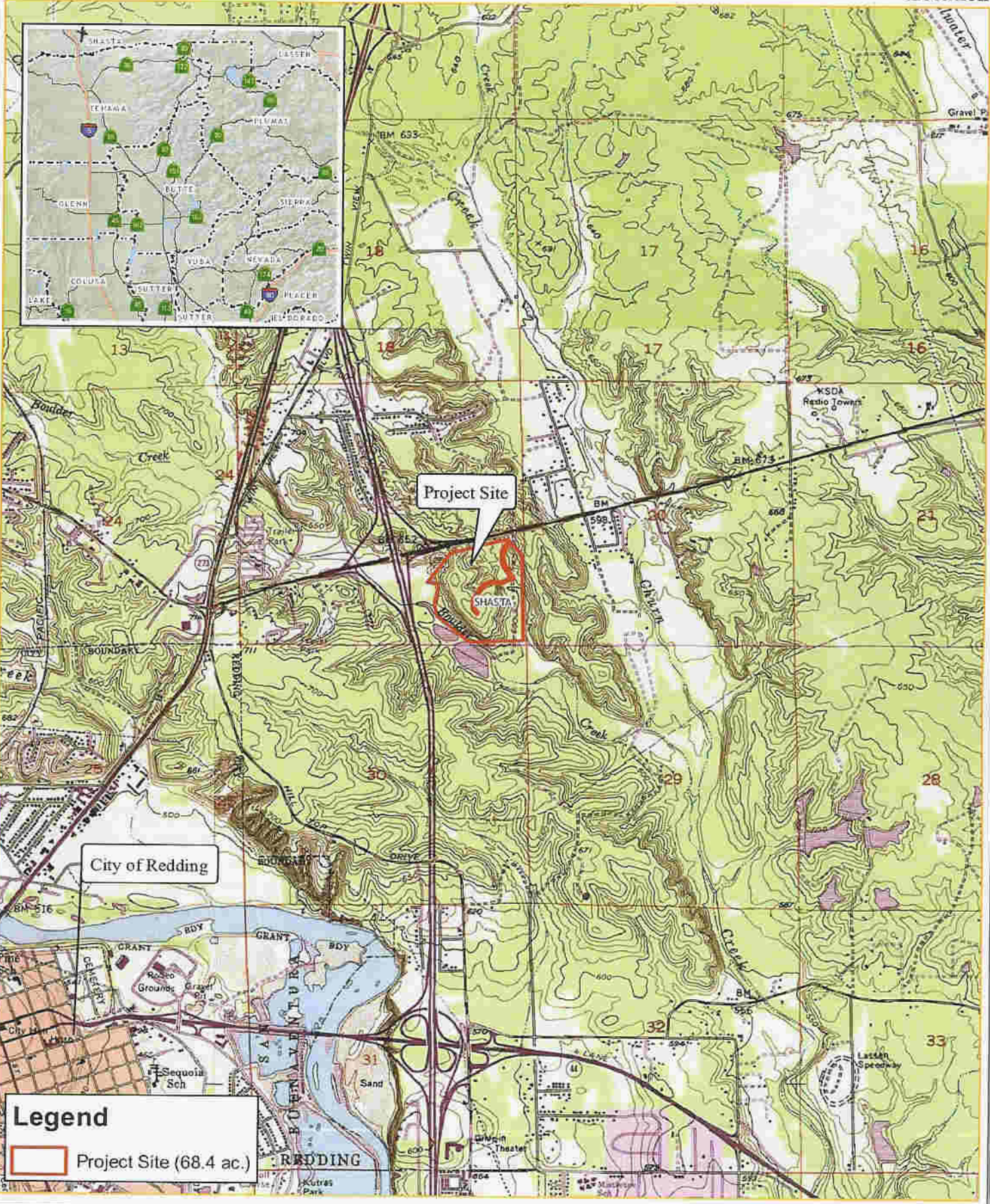
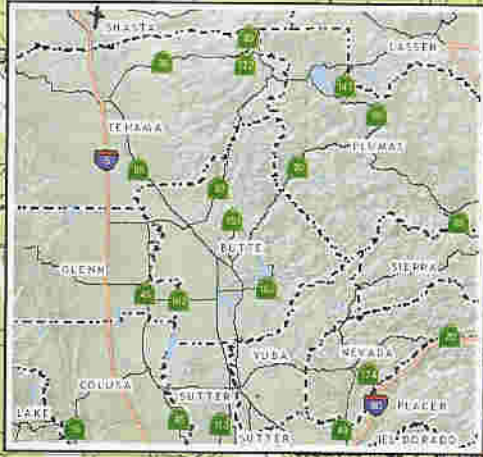
