Summarize overall biological, chemical and physical functions being performed: Seasonal wetlands retain and filter flow conveyed within a swale which discharges to a storm drain which discharges to Kaseberg Creek. May provide some habitat, but diversity within the seasonal wetlands is low.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The seasonal wetlands do not have the capacity to provide habitat and lifecycle functions to species present in the Sacramento River due to the separation between the seasonal wetlands and Kaseberg Creek by the storm drain. Kaseberg Creek does have the capacity to provide habitat and lifecycle functions to species present in the Sacramento River. The seasonal wetlands have the capacity to transfer nutrients and organic carbon that support downstream foodwebs. Kaseberg Creek is tributary to Pleasant Grove Creek, which is tributary to Cross Canal, which is tributary to the Sacramento River, a navigable water of the United States.
