**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. 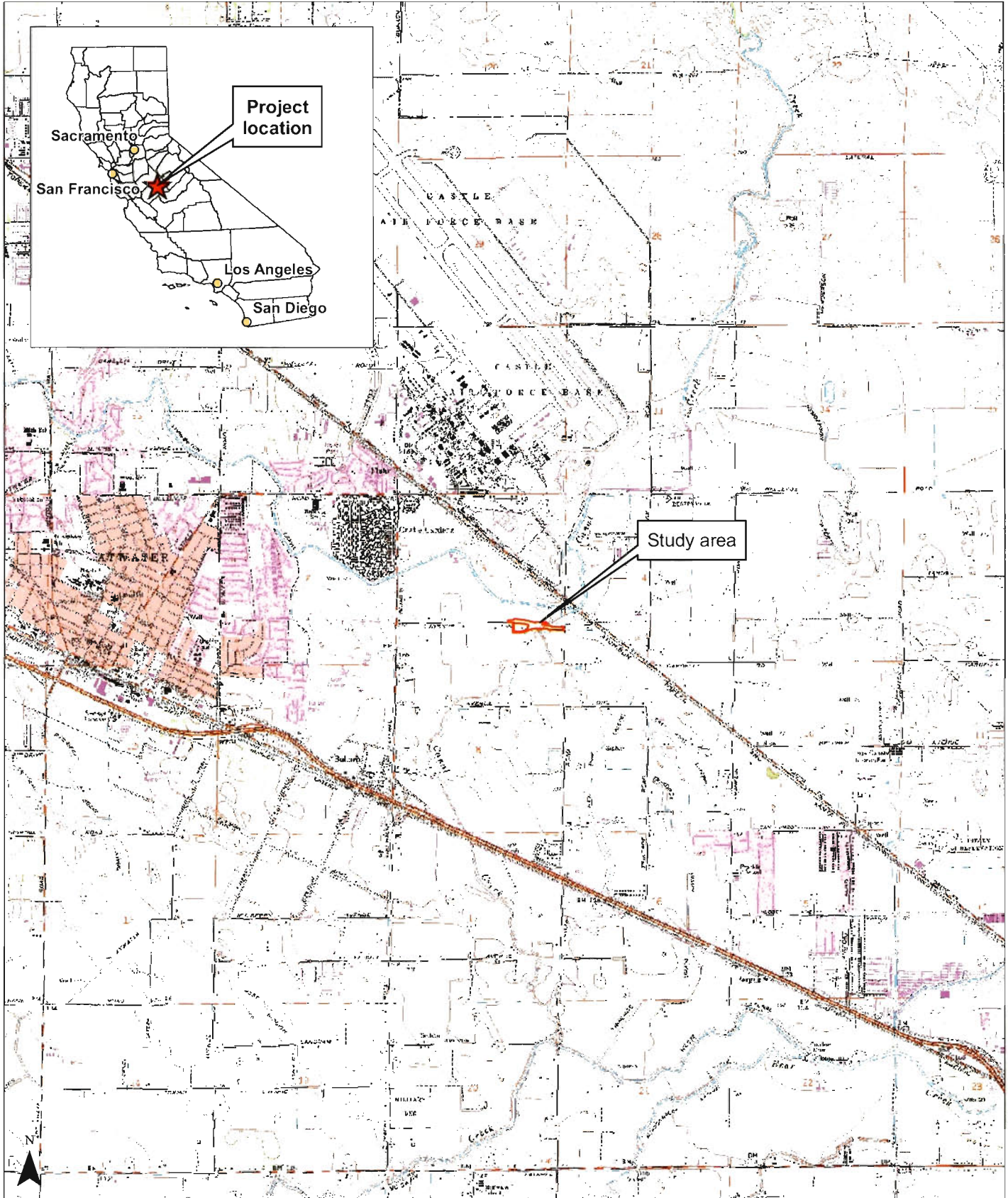

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

**The isolated wetland (WL 6) does not have any apparent connection to Canal Creek. There is no flow between this wetland and the creek, nor is there a significant nexus with interstate commerce. This wetland is also isolated from all other wetlands on site by approximately 325 feet of upland agricultural field. The Armas Lateral flows into agricultural fields and does not convey flows into any jurisdictional waters. Although the lateral appears to receive water from Canal Creek, it never connects to any other waterway. The lateral is not used for any form of interstate or foreign commerce and the water is used solely for irrigation.**

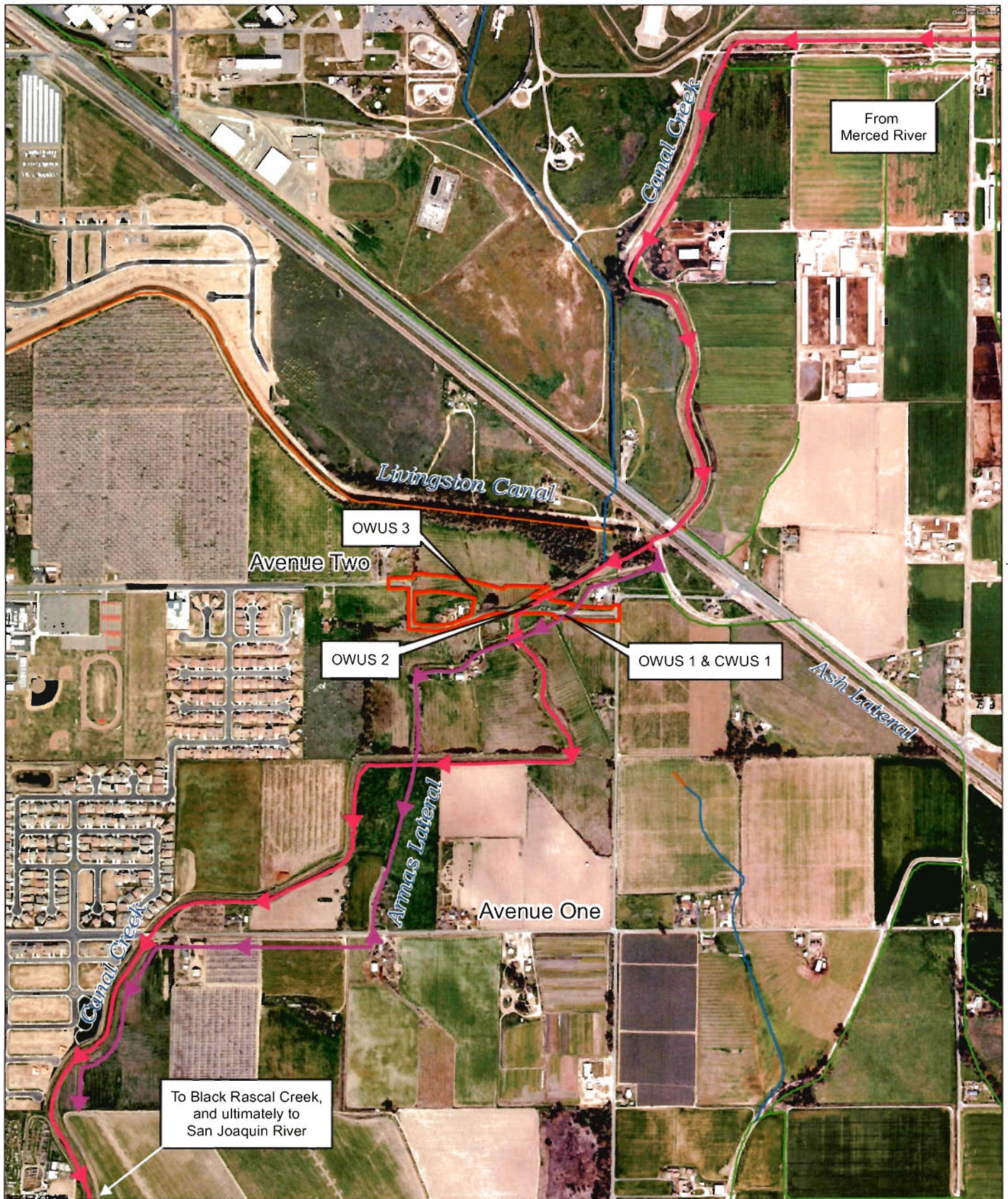

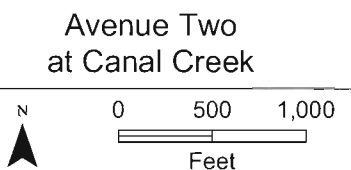
