Summarize overall biological, chemical and physical functions being performed: The overall functions are typical of any irrigation ditch system. They provide a supplemental source of water, and minor habitat and food sources. The overall biological impact is not expected to be important because other natural water sources with a riparian community are nearby. The physical function is to convey and distribute water to irrigated areas. There are no notable chemical functions associated with the ditches.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

There are two perennial RPWs, the Malad River and the Corrine Canal, which will be addressed in a separate JD form; additionally there are two isolated wetlands which is sited within the same wetland swale that has previously been confirmed to be isolated by EPA and Corps Headquarters, Corps number: 200800023. The subject irrigation ditches are not perennial and the water flows in these ditches is regulated by the irrigation district. Two wetlands abut the irrigation ditch: one is 0.01 acres and one is a long, linear wetland on both sides of the 0.47 acre wetland. The irrigation ditches all directly discharge into regulated waters; flows in these ditches originate from and discharge into the Corrine Canal or Malad River. The Malad River and Corrine Canal discharge directly into the Bear River which is confluent with the Great Salt Lake, a traditional navigable water – navigable-in-fact water. The survey corridor was 7.4 miles long and 100 feet wide, about 89 acres. Three separate jurisdictional forms were completed for this project: one for Malad River and Corrine (irrigation) Canal (a perennial RPW tributary); one for intermittent irrigation ditches (a seasonal RPW tributary); and one for an isolated wetland. This determination is for the intermittent irrigation ditches..
