C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

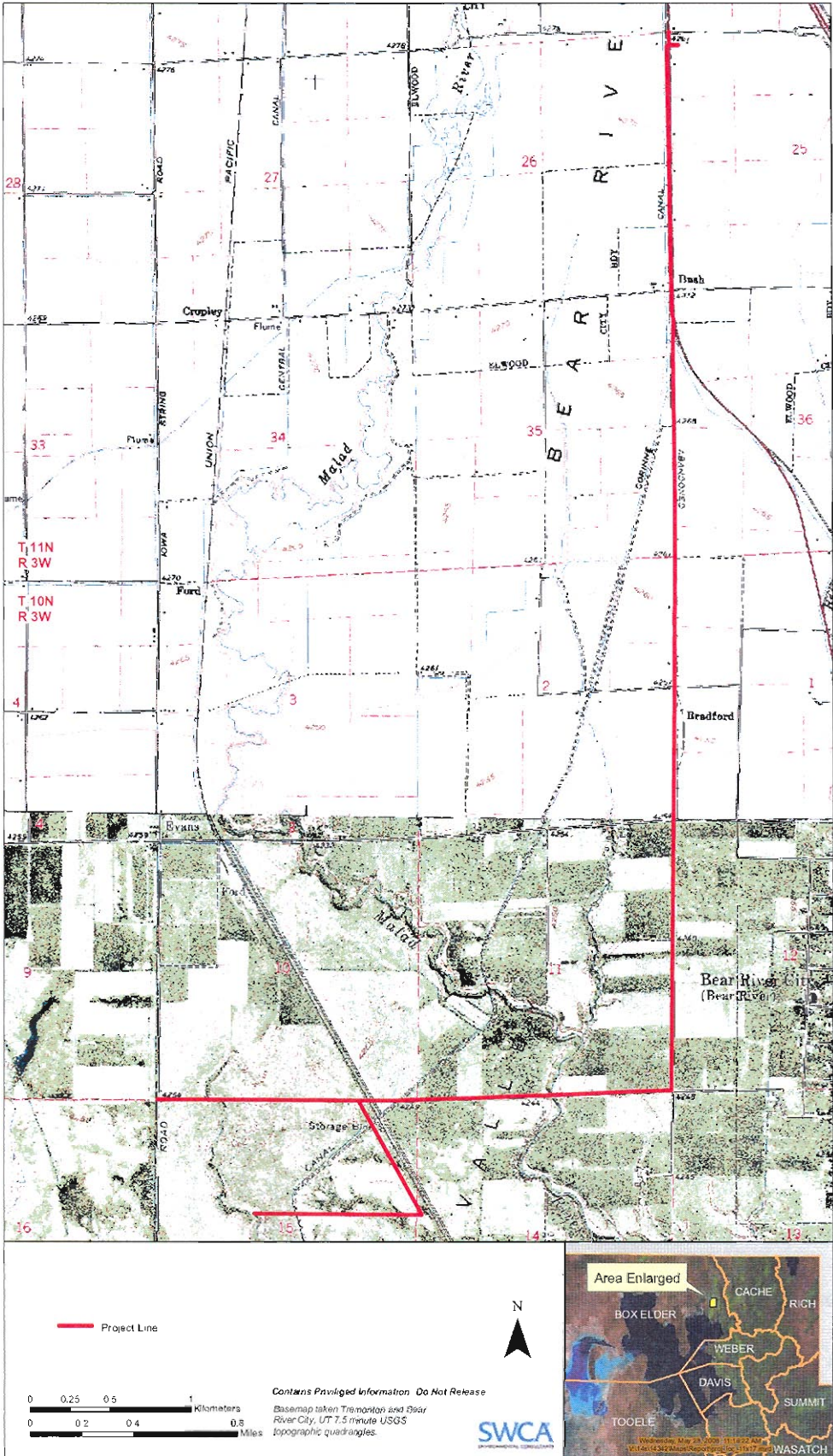

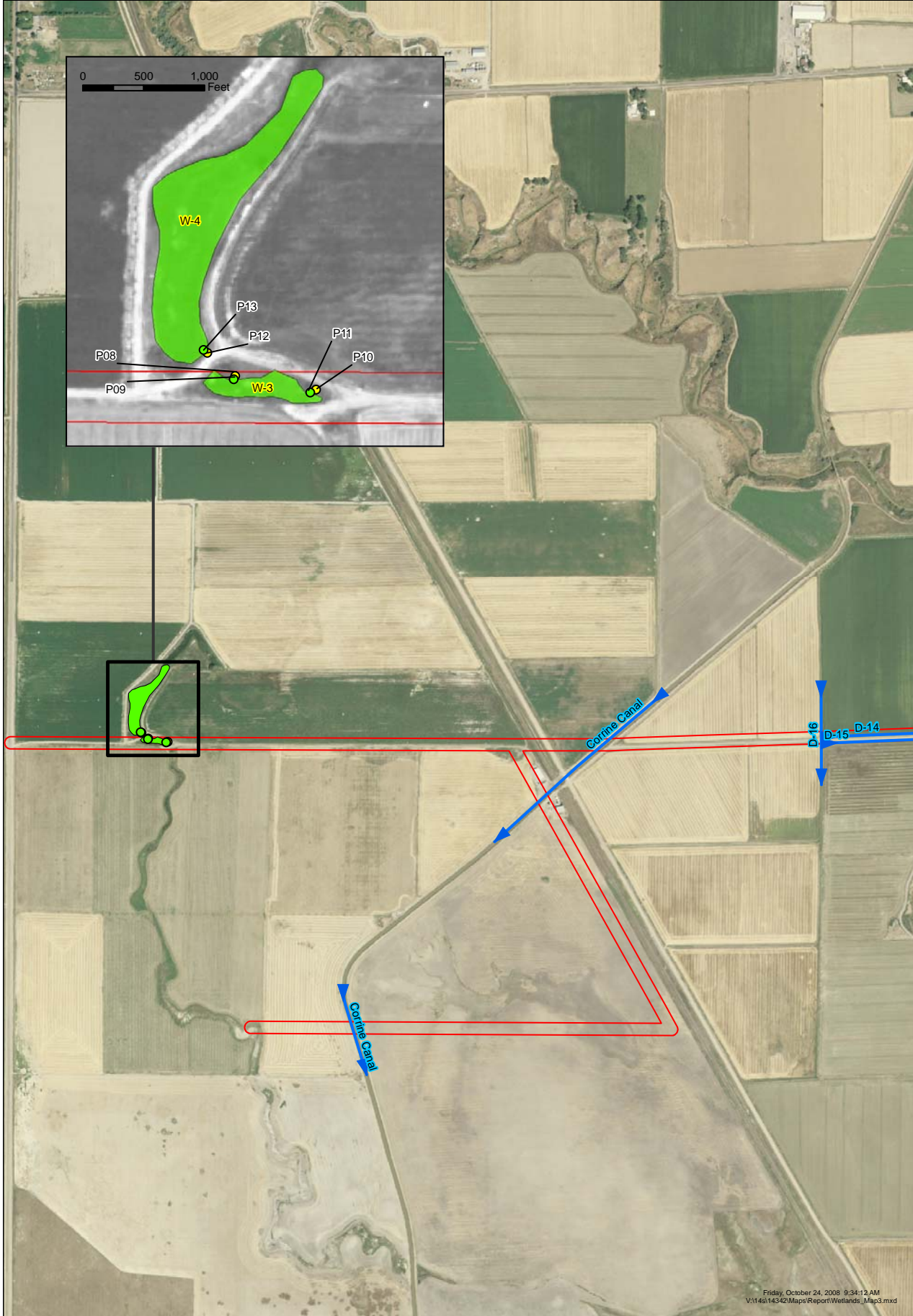

B. ADDITIONAL COMMENTS TO SUPPORT JD: The two subject wetlands, Wetland 3 which is 0.19 acres and Wetland 4 which is 1.77 acres, are part of a larger wetland swale that has previously been determined to be an isolated, intrastate wetland swale with no connection to a regulated tributary. Both these wetlands are at the northern end of this wetland swale, estimated to be about a mile long. Furthermore, these are palustrine emergent wetlands that rarely have water above the surface, particularly deeper than a few inches for more than a month. Extensive testing protocols were used to confirm this wetland swale was isolated from the Corrine Canal and the Malad River. It is noted that Wetland 4 is nearly all outside the project review area, however the consultant opted to delineate this wetland and seek an approved jurisdictional decision on it. At the southern end of this wetland swale, the Corinne Canal is flumed about 6-10 feet above swale. While it is conceivable that leakage from the canal may supplement water in this swale, there is no evidence that water from swale contributes water to the canal, based on dye testing and well monitoring. Also, the aerial photograph, provided by the consultant, shows there is still a remnant channel, likely the historic stream channel. However the channel has been highly disturbed from agricultural practices, no longer exists nor has any bed and bank characteristics, and does not contribute surface (or shallow subsurface) flows downstream where it could potentially contribute flows to a regulated, downstream tributary system. Three separate jurisdictional forms were completed for this project: one for Malad River and Corrine (irrigation) Canal (a perennial RPW tributary); one for intermittent irrigation ditches (a seasonal RPW tributary); and one for an isolated wetland. This determination is for the isolated wetland..
