The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The two perennial waters in the survey area are the Corrine Canal and Malad River. The Corrine Canal receives water from Bear River diversions and directly discharges back into the Bear River after supplying numerous seasonal irrigation ditches with water. The Malad River is perennial and is confluent with the Bear River. The Bear River is confluent with the Great Salt Lake, a traditional navigable water – navigable-in-fact water. It is noted that within the survey boundary, there are several irrigation ditches and their two abutting wetlands as well as two isolated wetlands (Wetlands 3 & 4) which are being addressed in separate JD forms. Three separate jurisdictional forms were completed for this project: one for Malad River and Corrine (irrigation) Canal (a perennial RPW tributary); one for intermittent irrigation ditches (a seasonal RPW tributary); and one for an isolated wetland. This determination is for the Malad-Corrine Canal..
