**2. Non-regulated waters/wetlands (check if applicable):<sup>3</sup>**

- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Three small areas were identified with the project survey and evaluated in this jurisdictional form. All are remnant ephemeral tributaries that no longer have any surface connection to a regulated tributary system, but they do sometimes collect and retain water after storm events. They typify drainages that are in the transition zone between steeply sloped foothills and the gently sloped alluvial fan. In general, many tributaries in the project area appear as erosion gullies without characteristic bed and bank features and transition to a generalized swale that does not confine flows in a channel. The three small areas identified on this form are three physical features whose channel bisected the project review area. They are not jurisdictional because they no longer are part of a regulated tributary system. The**

primary regulated tributary downstream from these areas is the Jordan River. Topographic maps suggest these tributaries never reached the Jordan River. If they would have, the connection has been severed long ago by development that has reshaped this flatter topography.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The overall jurisdictional review along the 7½-mile project review area shows there are three kinds of potentially regulated waters of the United States: Relatively Permanent Waters (and canals); Isolated Waters (tributaries with no surface or obvious subsurface connection to a regulated tributary); and upland sites (low portions of the topography that trap surface flows). This JD form addresses the Isolated Waters. They are determined to be isolated with no connection to a regulated All are remnant ephemeral tributaries that no longer have any surface connection to a regulated tributary system, but they do sometimes collect and retain water after storm events. They typify drainages that are in the transition zone between steeply sloped foothills and the gently sloped alluvial fan. In general, many tributaries in the project area appear as erosion gullies without characteristic bed and bank features and transition to a

generalized swale that does not confine flows in a channel. The three small areas identified on this form are three physical features whose channel bisected the project review area. They are not jurisdictional because they no longer are part of a regulated tributary system. The primary regulated tributary downstream from these areas is the Jordan River. Topographic maps suggest these tributaries never reached the Jordan River. If they would have, the connection has been severed long ago by development that has reshaped this flatter topography. Water (arbitrarily named) D5 is located on Sheet 2; D4 is located on Sheet 3, and D3 is located on Sheet 5. The sheets are part of the attachment to this JD. All tributaries are unnamed..
