Detentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Oak Creek is an isolated water. It is an intermittent/ephemeral stream that primarily carries spring runoff and occasionally flows during times of heavy rain. From aerial photos and USGS maps, it appears that any water conveyed by Oak Creek is diverted into the Central Utah Canal, which then appears to dissipate near Chalk Creek to the south. Any water reaching Chalk Creek either dissipates into various other canals or eventually terminates

into Sevier Lake- an intermittent lake that has been mostly dry throughout recorded history. (http://en.wikipedia.org/wiki/Sevier\_Lake). One online source mentioned that the Central Utah Canal "has not been in use since IPP power plant was built because they bought the water to use at the power plant". (http://www.geocaching.com/seek/cache\_details.aspx?guid=e6f884d0-070e-4949-a5b7-b80d87e9fa94) The project site is located on the eastern edge of the Sevier Desert, just west of the Canyon Mounains, near the eastern shoreline of ancient Glacial Lake Bonneville. The nearest TNWs, Mona Reservoir, Sevier Bridge Resevoir (Yuba Lake), and Piute Reservoir are approximately 40 miles northeast, 17 miles east and 75 miles southeast of the project site, respectively. Mona reservoir is located in a different watershed and both Piute and Sevier Bridge (Yuba Lake) Reservoirs are located upstream of Oak Creek.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

#### **B. ADDITIONAL COMMENTS TO SUPPORT JD:**

Water conveyed by Oak Creek does not flow into a TNW. After being diverted into the Central Utah Canal, flow is dispersed or terminates near Chalk Creek to the south. Flow that reaches Chalk Creek terminates at or before Sevier Lake. If Oak Creek were allowed to return to its natural channel it would flow into the Sevier River which also terminates in Sevier Lake. Sevier Lake has been a dry lake bed for decades. The Corps has determined Oak Creek to be an intrastate isolated water and there are no apparent interstate commerce connections. Several online searches were conducted regarding Oak Creek's connection to interstate commerce- all of which provided no results. A review of other available information also provided no results. Oak Creek is an intermittent/ ephemeral stream, eliminating the possibility of a connection to interstate recreation. If there was enough water in the channel to be tied to interstate commerce, there is no information available to support a claim that degradation of such waters would adversely affect interstate commerce.
