Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **Multiple small drainage ditches are contained within the project site, totalling 0.199 acre, and do not connect to waters of the US or other potentially jurisdictional waters. These ditches appear to capture water around the storage ponds. One central ditch identified as features DDI-3 through -7, DDI-9 and Pond-1 (2.993 acres total), functions as the central irrigation system with a pump at the southern end. It was unclear where the water was coming from and was actively being pumped into the ditch during the site visit. The water within this ditch does not connect nor flow to any of the potentially jurisdictional waters on site. There are also seven additional small to medium irrigation ponds, ranging in size from 0.296 to 4.511 acres, located throughout the site. These ponds total**

19.382 acres and are elevated with the bottom of the pond at or above ground level. The ponds are man made and only receive water that is pumped over the berms into the ponds.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
