A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Wetland ep18 drains through a culvert under a road directly into a remnant blue-line channel mapped on the USGS topographic map. At the time of the site visit the section of the blue-line stream visible from the road was inundated with water and had California tiger salamander (CTS) larvae simming in it. However the area looked more like ponding of agricultural runoff than a channel - there was no defined bed or bank. On the USGS topographical map the channel is mapped as traversing land that is currently planted in citrus orchard and then flowing into Cottonwood Creek. Cottonwood Creek drains into Cross Creek which flows into the Tulare Lakebed.




Wetland ep18 which flows through a culvert under the road into a remnant blue-line stream which is shown on the USGS topo as connecting to Cottonwood Creek







