The basin does meet the three characteristics of a wetland as described in the 1987 manual, however it is isolated with no apparent connectivity to any RPW or TNW. There are two pipes that serve as drainage outlets into the pond. They appear to collect agricultural runoff from the nearby orchards. The pond does not appear to drain into any other feature.

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. B. ADDITIONAL COMMENTS TO SUPPORT JD:

The unlined ponding basin does meet the three parameters for a wetland according to the 1987 manual. However it appears to be constructed in uplands and to have no hydrologic connectivity to a RPW or TNW. Draiange pipes bring agricultural runoff from the nearby orchards into the ponding basin; there is no outlet for ponding basin waters. The ponding basin is surrounded by orchards on three sides and by a road on the fourth.



The feature labeled 'pb31' is an isolated, unlined agricultural pond fed by two drain pipes and surrounded on three sides by orchard, and by a road on the fourth.
