The channel labeled 'dcCh5' by the applicant is a natural drainage channel with an Ordinary High Water Mark (OHWM) and flowing water at the time of the site visit. The channel is mapped on the USGS topographic map, however it ends abruptly and has no connection to any other channels. When the channel was followed on foot it was found to cease to carry flowing water, then to lose its OHWM, then any sign of soil moisture was eliminated until the land was merely upland.

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. 
B. ADDITIONAL COMMENTS TO SUPPORT JD:

Wetland swale 'sw39' collects water running down from the nearby hillside and concentrates it into drainage channel 'dcCH5.' The channel is mapped on the USGS topographic map but ends abruptly without any connection to a downstream channel. The channel labeled 'dcCh5' by the applicant is a natural drainage channel with an Ordinary High Water Mark (OHWM) that is fed by water collected from the hills above the project site in swale 'sw39' and flows down though and past the project site before ending in uplands. There was flowing water in the channel at the time of the site visit. The channel is mapped on the USGS topographic map, however on the map it ends abruptly and has no connection to any other channels. When the channel was followed on foot it was found to cease to carry flowing water, then to lose its OHWM, to criss-cross and sometimes merge with a cattle trail, then any sign of soil moisture was eliminated until the land was merely upland grassland and the only thing that interrupted the continuous grassland was the dry cattle trail.







