Note that the channel waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The channel mapped by the applicant, dcCH8, is a natural drainage channel with an Ordinary High Water Mark. However, the channel is not mapped on the topographic map. A site visit revealed that the channel began on an adjacent hill and flowed down the hill until the channel flattened out in grassland and seemed to disappear. There is an adjacent cattle trail that intersects with dcCH8 in segments but the channel and trail diverge again before the channel ends. During the site visit there was a two foot stretch of the cattle trail where the soil was moist, downhill of where channel dcCH8 had appeared to end. The moist soil may be a sign of subteranean flow, even

though an examination of aerial photos showed the channel to be short in length and not connected to any other tributaries.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

# B. ADDITIONAL COMMENTS TO SUPPORT JD:


The channel dcCH8 is not mapped on the USGS topographic map. The channel begins in the nearby hill and flows down, periodically joining with and then deviating from an adjacent cattle track. For the majority of its length the channel has an Ordinary High Water Mark but as the slope of the hill flattens out the channel also becomes more shallow until it completely flattens out and appears to end in upland grassland. During the site visit, downslope of where the channel ends, there was a two-foot section of the cattle track where the soil was moist, raising the question of potenial subterranean flow. The moist soil may be a sign of subteranean flow, even though an examination of aerial photos showed the channel to be short in length and not connected to any other tributaries.





Upstream view of channel 'dcCH8.'




Downstream view of channel 'dcCH8.'










