The channel dcCH16 is a natural drainage channel that starts on the hill behind and ends abruptly in a low-gradient upland slope. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. 





Two photos showing channel dcCH15. The channel comes off the hill and gradually disappears into upland grassland.







