This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent

wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

There is a total of 0.425 acres of waters of the United States within the study area.

Features 1 through 5 and W1 consist of 0.074 acres of RPWs and an open water pond that drain directly into Lake Tahoe, a Section 10 Traditional Navigable Water of the United States. Glenbrook Creek (Features 1 through 3) and its tributaries (Features 4, 5, and W1) flow year-round, persisting through dry summer months. There are 657 linear feet of these channels within the study area that range from 1 to 6 feet wide.

Features A and B consist of 0.351 acres of wetlands directly abutting Glenbrook Creek and its tributaries. The wetlands are continuous with Glenbrook Creek, and there are no berms, dike, etc. that separate the wetlands and the stream. Feature A is an emergent floodplain wetland that is perennially saturated and is sustained by surface flows from Glenbrook Creek. Feature B is a riparian floodplain wetland directly abutting Feature 3 through 5 and W1 which is supported by vertical fluctuation in the groundwater table and direct inundation from the stream channels during high flow events.
