This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

#### **B. ADDITIONAL COMMENTS TO SUPPORT JD:**

Mesa Verde National Park is requesting a jurisdiction determination on a 0.31 acre wetland that is dominated by *Juncus arcticus* and *Bromus inermis*. The wetland has been degraded by the park's maintenance facility. The National Wetland Inventory map does not identify a wetland at the project area. The USGS Topographic Survey shows that an intermittent stream exists at the project location. However, potentially due to climatic changes and upstream development by the National Park Service, an ordinary highwater mark does not exist at the project site. In addition, there is no evidence of flow from the wetland area. Morfield Canyon is tributary to the Mancos River, which is a relatively permanent waterway that flows to the San Juan River, a traditional navigable in-fact waterway.
